Sir,

I have the honour to report that on 03/09/2019 at around 11:40 pm, received a reliable information from one of my informer that one **Md. Masleuddin @ Masle** aged about 29 years S/O Md. Qutubuddin of Pailapool Konthagaram, Cachar District P.O./P.S. Lakhipur A/P Lilong Bazar has been selling illegal drugs at his house and some quantities of the drugs are still at his house. Then I reduced the said information into writing and sent a similar copy to Superior Officers and inform him about the information through mobile phone. Then I also informed OC/LIL PS and volunteers of ALADA about the information. Later, I along with my team, a team of Lilong P.S. led by Inspector Oinam Ajit Singh, OC/LIL PS assisted by ASI Laishram Tikendro and the members of ALADA rushed to the said house. On reaching the said house at 12:20 am of 04/09/2019, the combined police team cordon the house very strictly and called out the family members of the house. In that one who identified himself as **Md. Masleuddin @ Masle** aged about 29 years S/O Md. Qutubuddin of Pailapool Konthagaram, Cachar District P.O. /P.S. Lakhipur A/P Lilong Bazar and one **Kh. Shahadat Ali (25)** S/O (L) Haji Nasib Ali of Lilong Bazar came out of the house. Then I informed them that our police team would like to conduct search of their house. With their consent the police team in the presence of civil witnesses started to search the house. On searching the house found blue colour bag containing some suspected items under the bed of one Md. Masleuddin. Then I take out the said blue colour bag and opened it in the presence of independent witnesses. On opening the blue colour bag in the presence of civil witnesses found, (1) one black colour plastic polythene containing blue colour cylindrical capsules suspected to be SP capsules, (2) one blue colour pouch containing reddish colour tablets suspected to be WY tablets and (3) 34 nos. of cough syrup bottles marked as "Codeine RTX- Care" and (4) one transparent plastic polythene containing some quantities of suspected Heroin No. 4 from the blue colour bag. In the meantime, I informed my Superior Officers about the incident. Then I counted the nos. of suspected SP capsules and found **356 (Three Hundred and Fifty Six)** nos. of suspected SP capsules weighing **230.6 grams**. And on counting the nos. of suspected WY tablets found **650 (Six Hundred and Fifty)** nos. weighing **68 grams** and the suspected Heroin No. 4 weighed 8 grams excluding the weight of the plastic container. The weights of the said drugs were measured in the weighing machine brought by us. Out of the 356 nos. of suspected SP capsules, 20 nos. of the suspected SP capsules were taken out and put inside two small transparent plastic packets with 10 nos. of the same capsules each, and again put one packet each inside two yellow envelopes, packed and sealed and marked as "S1" and "S2" respectively as Original and Duplicate Sample exhibits respectively. And the remaining 336 nos. of suspected SP capsules were put inside the original black plastic polythene and put inside another yellow envelope, packed and sealed and marked as "S" as Parent Sample exhibit. Similarly out of the 650 nos. of suspected WY tablets 20 nos. of the suspected WY tablets were taken out and put inside two small transparent plastic packets with 10 nos. of the same tablets each, and again put one packet each inside two yellow envelopes, packed and sealed and marked as "W1" and "W2" respectively as Original and Duplicate Sample exhibits respectively. And the remaining 630 nos. of suspected WY tablets were put inside the original blue colour pouch and put inside another yellow envelope, packed and sealed and marked as "W" as Parent Sample exhibit. Then out of the 34 Cough syrup bottles marked as "Codeine RTX- Care" 2 nos. of Cough Syrup bottles were taken out and put inside two yellow envelopes with one bottles each, packed and sealed and marked as "C1" and "C2" respectively as Original and Duplicate Sample exhibits respectively. And the remaining 32 nos. of Cough Syrup bottles were put inside one cartoon box wrapped with white cloth packed and sealed and marked as "C". Again out of the 8 grams of suspected Heroin No. 4, 4 grams of the same were taken out and put inside two transparent plastic packets with 2 grams each and again put inside two yellow envelopes with one packet each, packed and sealed and marked as "H1" and "H2" respectively as Original and Duplicate Sample exhibits respectively. And the remaining 4 grams of Heroin No 4 were put inside the original packets packed and sealed and marked as "H" as Parent sample exhibit. Therefore the packed and sealed drugs were seized from the unauthorised possession of **Md. Masleuddin @ Masle** aged about 29 years S/O Md. Qutubuddin of Pailapool Konthagaram, Cachar District P.O./P.S. Lakhipur A/P Lilong Bazar on the spot at 01:30 am of 04.09.2019 and also arrested the accused person on the spot 01:40 am. On spot interrogation, of **Md. Masleuddin @ Masle** aged about 29 years S/O Md. Qutubuddin of Pailapool Konthagaram, Cachar District P.O./P.S. Lakhipur A/P Lilong Bazar he disclosed that the said drugs belongs to them. Therefore **Kh. Shahadat Ali (25)** S/O (L) Haji Nasib Ali of Lilong Bazar was also arrested on the spot at 01:45 am. Hence all the packed and sealed drugs and the arrested accused persons were brought and handed over to Lilong Police Station for further necessary legal actions.
