Officer-In-Charge Lilong Police Station Thoubal District, Manipu On 18/09/2019 at around 10:30 pm received a specific input from one of my trusted informer that one Md. Nawas Khan (20) yrs S/o Md. Amir Khan @ Abir Khan of Lilong Usoipokpi Chaobok Lamkhai is selling illegal drugs like Heroine No. 4, WY tablets and Cough Syrup at his house. Then, I reduced the same information into writing and sent a similar copy to SP Thoubal and also informed him about the information through mobile phone. Immediately two teams of Lilong PS led by myself assisted by SI Md. Isha Khan of Lilong PS along with the members of Meira Paibies of Lilong Usoipokpi area rushed to the said spot. At about 10:45 pm on reaching at the house of Md. Nawas Khan our police teams cordoned the house very strictly and called out Md. Nawas Khan from his house. In that one youth came out from the house and later he identified himself as Md. Nawas Khan (20) yrs S/o Md. Amir Khan @ Md. Abir Khan. Then on questioning he admitted that he along with his mother namely Samim Banu is selling drugs Heroine no. 4 powder at his house for their wrongful gain. Our police team asked him to produce illegal drugs if he concealed for selling. Then he voluntarily produced one blue transparent plastic polythene bag from the backside of a refrigerator kept at the room of his father Md. Amir Khan @ Md. Abir Khan.

On opening the blue plastic polythene in the presence of civil witnesses found, one transparent bottle marked as "Glycerin" containing suspected to be Heroin No. 4 powder inside the blue plastic polythene bag. In the meantime, I informed my Superior Officers about the incident. Then I weighted the suspected Heroin No. 4 powder and it weighed 5.2 grams. The weight of the said Heroin No. 4 powder were measured in the weighing machine brought by us.

Out of the 5.2 grams of suspected Heroin No. 4 powder, 2 grams of the suspected Heroin No. 4 powder were taken out and put inside two small transparent plastic packets with 1 gram of the same Heroin No.4 Powder each, and again put one packet each inside two yellow envelopes, packed and sealed and marked as "H1" and "H2" as Original and Duplicate Sample exhibits respectively. And the remaining 3.2 grams of suspected Heroin No. 4 powder were put inside the original transparent bottle marked as "Glycerin" and again put the same inside the blue plastic polythene bag and put inside another yellow envelope, packed and sealed and marked as "H" as Parent Sample exhibit respectively.

Then the packed and sealed yellow envelopes were seized from the unauthorised possession of Md. Nawas Khan (20) yrs S/o Md. Amir Khan of Lilong Usoipokpi Chaobok Lamkhai on the spot at 11:15 pm in the presence of civil witnesses and also arrested the accused person on the spot 11:25 pm.

Hence all the packed and sealed drugs and the arrested accused person were brought to Lilong Police Station and registered a case under FIR No. 99(09)2019, LIL PS U/S 21(b)/29 ND & PS Act.
