Sir,

I have the honour to report that today ie, 01/10/2019 at around 02:00 pm, received a reliable information from my own source that **one Md. Azizur Rahman @ Doctor Rotho** aged about 50 years S/o (L) Md. Obedullah of Lilong Haoreibi Chandakhong has been selling illegal drugs at his house and some quantities of the drugs are still at his house. Then, I reduced the said information into writing and sent a similar copy to Superior Officers and OC/LIL-PS. Then I also informed volunteers of ALADA about the information. Then immediately, I along with my police team of Lilong P.S. led by OC/LIL-PS and the members of ALADA under the supervision of SP/Tbl rushed to the said house. On reaching the said house at 02:30 pm, my police team cordon the house very strictly and called out the family members of the house. In that, one who identified himself as **Md. Azizur Rahman @ Doctor Rotho** aged about 50 years S/O (L) Md. Obedullah of Lilong Haoreibi Chandakhong came out of the house. Then I informed him that our police team would like to conduct search of his house. With his consent the police team in the presence of civil witnesses started search the house. On searching the house found a bottle marked as "Novitas" cylindrical plastic containing some suspected items inside the bottle at his bedroom under his drawer box. Then I took out the said bottle and opened it in the presence of independent witnesses. On opening the bottle in the presence of civil witnesses, found some powder suspected to be Heroin No. 4 inside the bottle. On questioning, he disclosed that the same powder suspected to be Heroin No. 4 is belongs to him. In the meantime, I informed my Superior Officers about the incident. Then I weighed the suspected Heroin No. 4 powder and it is 5.2 grams excluding the weight of the bottle container. The weight of the said drug was measured in the weighing machine brought by us.

Out of the 5.2 grams of suspected to be Heroin No. 4, 2 (two) grams of the same were taken out and put inside two transparent plastic packets with 1 (one) grams each and again put inside two yellow envelopes with one packet each, packed and sealed marked as "H1" and "H2" as Original and Duplicate Sample exhibits respectively. And the remaining 3.2 grams of Heroin No.4 were put inside the original packet and again put inside one yellow envelope packed and sealed marked as "H" as a Parent sample exhibit. Therefore the packed and sealed drugs were seized from the unauthorised possession of **Md. Ajijur Rahman @ Doctor Rotho** aged about 50 years S/O (L) Md. Obedullah of Lilong Haoreibi Chandakhong on the spot at 03:45 pm and also arrested the accused person in the spot at 03:50 pm. On spot interrogation of **Md. Azizur Rahman @ Doctor** aged about 50 years S/O (L) Md. Obedullah of Lilong Haoreibi Chandakhong, PO & PS Lilong, District- Thoubal, Manipur, he disclosed that the said drug was taken from one Mr. Anil of Kakching Bazar and he further sells to the localities as well as to consume his personal use.

Hence the packed and sealed drug and the arrested accused persons are brought at Police Station for further necessary legal actions.
