Sir,

I have the honour to report that today i.e 12/10/2019 at about 06:45 pm received credible information that some members of gang arms dealers are loitering at Lilong bazar area. On receiving the information, organized a joint combined team of commando unit Thoubal comprising I myself, SI Ramesh, and HC Kh. Rakib, led by Inspector N. Sadananda Singh OC-CDO/Thoubal and two column of 6 AR led by Major Sourabh Poddar, under the overall supervision of Shri Dr. S. Ibomcha Singh, MPS Superintendent of Police Thoubal District, immediately rushed to the said area and conducted search of suspected persons. While frisking and checking one unknown person was coming from Lilong Bridge toward Lilong Bazar in a very suspicious manner. Due to his suspicious nature, the unknown person was detained for verification.

On preliminary verification, the unknown person identified himself as Md. Riyajuddin @ Tomba(38) yrs. S/o. Md. Basiruddin of Lilong Turel Ahanbi Mayai leikai an arm dealer. Further he disclosed that he kept 2 (two) AK rifles with one magazine each and 1(one) 9mm pistol with magazine at his house for selling purpose only. Hence, he was arrested at 7:30 pm of 12/10/2019 from Lilong Bazaar by observing formalities.

On follow up action, 2 (two) AK rifles with one magazine each and 1(one) 9mm pistol with magazine were recovered from his house and seized the same from his house by preparing formal seizure memo.

The arrested person mentioned above along with seized articles have been handed over to you for taking further necessary legal action against him.
