Subject: - Report

Sir,

I have the honour to report that on 15/10/2019 at around 11:50 pm received a reliable information from my source stating that one **Md. Abdul Latip** aged about 40 years S/O Md. Nasib Ali of Lilong Haqreibi Turel Ahanbi Darul Uloom Maning is selling illegal drugs at his house and some quantities of the said drugs are still at his house. I quickly reduced the source report into writing and sent a similar copy to my superior officer. Also I verbally intimated the information to SP Thoubal on mobile phone. Then immediately, I along with a team of Lilong Police Station led by ASI Laishram Tikendro of Lilong P.S. and the volunteers of ALADA under the strict supervision of SP Thoubal rush to the house of Md. Abdul Latip before obtaining search authorization as there are huge chances of concealing the illegal drugs and also escaping the culprits. On reaching the house at around 12.15 am 16/10/2019 the combine team cordon the house and called out the family members, in that one person who identified himself as one Md. Abdul Latip came out of the house. Then I informed him that our police team would like to conduct search of his house. With his consent the police team entered the house and search the house in the presence of civil witnesses.

On searching his bed found one drawer made to keep concealed some articles under his bed. On opening the drawer found one black colour polythene containing 3 transparent plastic packets containing small empty plastic containers normally use for keeping Heroin no. 4 labeled as "KUNDU UPATN 144 pcs" and one transparent plastic polythene containing yellowish powder substances suspected to be Heroin No. 4. On weighing the yellowish powder on the weighing machine brought by us, it weighed 25 grams. Out of which 2 grams of the same were taken out and put inside two yellow envelopes with 1 gram each, packed and sealed and marked as "H1" and "H2" as original and duplicate sample exhibits and the remaining 23 grams of the same were put inside the original plastic packet and again put inside another yellow envelope marked as "H" as Parent sample exhibit. And the 3 transparent plastic packets containing small empty plastic containers normally use for keeping Heroin no. 4, labeled as "KUNDU UPATN 144 pcs" marked as "A", "B" and "C".

Therefore the packed and sealed drugs along with the 3 nos. of empty plastic containers containing in transparent plastic packet were seized by preparing a formal weighing & seizure memo in the presence of civil witnesses at 01:05 am of 16/10/2019 and later arrested him on the spot at 01:10 am of the same day by observing formalities.

Hence the all the seized drugs and articles along with the arrested accused person were brought to Lilong Police Station and handed over to you for necessary legal action against him.
