Today i.e. 17/10/2019 at 04:45 pm received a reliable information that on the same day at around 04:40 pm one Tata DI Xenon silky silver in colour bearing registration no. MN01G-7079 which was proceeding from Imphal side towards Thoubal side dashed one two wheeler Mini Suzuki Lets black and red in colour bearing registration No. not known at Lilong Tairen Makhong along NH-102 due to rash and negligent driving on the part of unknown driver of Tata DI Xenon. As a result of which, the rider of the Suzuki Lets was seriously injured on his persons and evacuated to the hospital for medical treatment however succumbed to his injuries on the way to hospital. The involved two wheeler Suzuki Lets was partly damaged.

Hence a Sou moto case under **FIR No. 110(10)2019 LIL-PS U/S 279/338/427/304-A** IPC is registered for investigation.
