Sir,

With due respect, I have the honour to state that on 28/10/2019 at about 09.30 am on receiving a reliable information from my own source that one namely Laishram Rohenjit Meitei (19)yrs S/o L. Maniton Meitei of Waithou Saijin Pallak A/P Lilong Arapti Mayai Leikai is owing a stolen Honda Dio Grey in colour and further the informer also informed me that the person was driving the said vehicle from Waithou towards Lilong Bazar, then I along with a team of Lilong PS were conducting Frisking & Checking in front of Lilong PS gate on NH-102, at the meantime one unknown person was coming from Waithou side towards Lilong Bazar side by riding a Honda Activa Grey in colour having regn. no. NIL. The said unknown rider of the Honda Dio Grey in colour was detained for verification. On verification the said unknown person was identified as Laishram Rohenjit Meitei (19)yrs. S/o L. Maniton Meitei of Waithou Saijin Pallak A/P Lilong Arapti Mayai Leikai. On further checking of the vehicle Honda Dio, found its engine no. as JF39E72066794 and Chassis no. as ME4JF39EHH7013687. The rider of the Honda Dio could not produced any relevant document of the vehicle. On further interrogation of the said person, he disclosed that the said vehicle was purchased from one unknown person of residence at Lilong Haorou Hangamthabi at the price of Rs.25,000/- (Rupees Twenty five thousand)only. On purchasing the said vehicle from the unknown person he(the rider of the Honda DIO) did not signed any sale deed in between the registered owner of the vehicle and the said person. So, the said person was arrested and seized the vehicle Honda Dio from spot.

It is therefore, requested to take necessary legal action against him.
