Sir

I have the honour to report that today i.e. 03/11/2019 at around 11:50 am, received a reliable information from my own source that there is present of vehicle lifters at Lilong Ushoipokpi Bazar. As such, under the supervision of Inspt. O. Ajit Singh, OC/Lilong, I along with police team of Lilong PS rushed to the said area. On reaching at Lilong Ushoipokpi Bazar, vehicle lifters numbering 4 (four) persons who are loitering in the area fled away by leaving one Alto car blue in colour Bearing Regd. No. WB02N-9876. Our police team managed to detain one person out of 4 (four) vehicle lifters. On spot verification he identified himself as Kh. Mubinur Rahaman (18) yrs, S/o. Kh. Mujibur Rahaman of Lilong Litan Makhong. He disclosed that he along with the 3 (three) persons namely 1) Md. Kheiruddin aged about 25 yrs, S/o. Unknown of Lilong Dam, 2) Md. Aten aged about 25 yrs, S/o. Unknown of Lilong Dam and 3) Md. Imtiyas Khan aged about 25 yrs, S/o. Md. Aboton of Lilong Litan Makhong had stolen many vehicles by using the Alto car blue in colour Bearing Regd. No. WB02N-9876. Hence he was arrested from the spot at 12:35 pm by observing formalities and also seized the Alto car blue in colour Bearing Regd. No. WB02N-9876 at 12:40 pm from his possession.

So the arrested person along with the seized vehicle is being handed over to you for further necessary action.
