Today i.e. 09/11/2019 at 02:15 pm received reliable information that on the same day at around 02:10 pm one Tata Mini Bus white in colour bearing registration No. MN03-0106 which was proceeding from Thoubal side towards Imphal side dashed one Honda Activa blue in colour bearing registration No. Nil and one Diesel Auto black in colour bearing registration No. MN01AB-0239 which are coming in the opposite direction at Lilong Tairen Makhong along NH-102 due to rash and negligent driving on the part of unknown driver of Tata Mini Bus. As a result of which, the rider of the Honda Activa and occupants of the Diesel Auto got serious injuries on their persons. The rider of the Honda Activa succumbed to his injuries on the spot and occupants of the Diesel Auto were evacuated to the hospital for medical treatment. The involved Honda Activa and Diesel Auto were partly damaged.

Hence a sou moto case under **FIR No. 117(11)2019, LIL-PS U/S 279/338/427/304-A IPC** is registered for investigation.
