
Sir,

I have the honour to report that on 09/11/2019 at about 09:30 pm one two wheeler Suzuki Access white in colour bearing registration no. MN01F/2972 driven by Md. Ningthou aged about 38 yrs. S/o Haji Abdul Manan of Lilong Ubakthong coming from Lilong Bazar side towards Lilong Ushoipokpi side dashed upon one pedestrian my son namely Md. Sadik Rahman aged about 25 yrs. S/o Md. Atabur Rahman of Lilong Chaobok Mairenkhun coming in the same direction along the NH-102 at Lilong Ushoipokpi Tathabi due to rash and negligent driving on the part of Md. Ningthou rider of the Suzuki Access. As a result of which, Md. Sadik Rahman aged about 25 yrs. S/o Md. Atabur Rahman of Lilong Mairenkhun sustained serious injuries on his persons and evacuated to the Noor Hospital, Lilong and later referred to the Raj Medicity, North AOC, Imphal. The involved vehicle got partly damaged.

So it is therefore requested to take up necessary legal action against the culprit rider of the wheeler Suzuki Access white in colour bearing registration no. MN01F/2972 at the earliest.
