Sir,

I have the honour to report that today i.e. 12/11/2019 at about 01:30 p.m. received a reliable information that some arms and ammunition are kept concealed by illegal Arm Manufacturer at Lilong area. Acting on the credible information, a joint team of Commando Unit Thoubal led by Shri Sachidananda Soibam, Addl. Superintendent of Police (Ops) Thoubal and Inspt. N. Sadananda Singh, Officer-in-Charge, Commando Unit Thoubal and a column of 26 AR led by Major Ram Dubey under the overall supervision of Shri Dr. S. Ibomcha Singh, Superintendent of Police, Thoubal District. Immediately rushed to the said area and conducted a thorough search at suspected places. In that, one unfamiliar package was found to be buried under foliage in a cave near Awal Masjid along Turel Ahanbi, Lilong Yangbi Leikai about 1½ km South of Litan Makhong . The package was remotely lifted and opened to reveal the following as:-

1. 1(one) Carbine Country made with magazine.
2. 1(one) 9mm Pistol Country made with magazine.

Seized the said articles at 02:15 p.m. of 12/11/2019 from the bank of Lilong river by preparing a formal seizure memo.

The above mentioned seized articles along with copies of seizure memo are handed over to you for taking further necessary action.
