Today i.e. 22/11/2019 at about 04:30 pm while I was at Lilong Police Station received reliable information that one drug peddler namely Sagolsem Hemanta Singh (35) s/o S. Romon Singh of Arapti Awang Leikai A/P staying at Langthabal Meitei Lamkhai is going to deliver a huge consignment of illegal drug i.e. codeine contained cough syrups at Lilong bazaar area. Accordingly, I recorded the information in writing and a copy of the same was furnished to my senior officer for information. Immediately, I along with Police Party rushed to the said place without obtaining search authorization as there was great chance of escape of the offender and concealing the drug. I also called upon some volunteers of All Lilong Anti-Drug Association (ALADA) at the place so as to witness the scene. On reaching at **Lilong bazar in front of PHC, Lilong**, at about 04:35 pm we saw that one suspected person was coming towards NII-107 from Arapti Lamkhai side and as suspicious, he was detained for verification. On verification, he disclosed himself as Sagolsem Hemanta Singh (35) s/o S. Romon Singh of Arapti Awang Leikai A/P staying at Langthabal Meitei Lamkhai who source man identified as drug peddler. On enquiry about the where about of the illegal cough syrups, he disclosed that he delivered 144 Nos. of Bolirex cough syrup bottles to one Konthoujam Japan Singh @ Chitandra (35) s/o K. Joy Singh of Arapti Lilong Mapal, P.O/P.S- Irilbung, Imphal East just before few hours. He stated that he was coming just after the delivery of the consignment at the house of Konthoujam Japan Singh @ Chitandra. So, he was arrested at 04:45 pm and as the immediate search of the house of Konthoujam Japan Singh @ Chitandra was necessary to detect the illegal cough syrups, we along with Sagolsem Hemanta Singh and some volunteers of ALADA rushed at the house of Konthoujam Japan Singh @ Chitandra after giving information to Police Control Room (PCR), Imphal East through PCR, Thoubal. On reaching the house at about 05:15 pm we called out the family members of the house, in that one person came out of the house and identified himself one Konthoujam Japan Singh @ Chitandra (35) s/o K. Joy Singh of Arapti Lilong Mapal, P.O.P.S- Irilbung, Imphal East. Then, I informed him that we have reason to believe that he had kept concealed some quantity of illegal cough syrups at his house and we would like to conduct house search. In presence of the witnesses, we conducted search of the house and during the search, found one nylon carry bag kept concealed at the corner of his bed room and it was opened in presence of the witnesses. On opening it, detected 144 Nos. of Bolirex cough syrup bottles (100 ml each) which contains 10 (ten) mg codeine phosphate per 5 ml each (as per composition) which is a contravened substance under ND&PS Act. On calculation/weighing, one bottle of Bolirex cough syrup contained $10 \times 20 = 200$ mg of codeine (as per composition). Then, two bottle of Bolirex cough syrup were taken out and put inside the two yellow envelops, packed and marked as "D1" & "D2" as original & duplicate representative samples respectively. The remaining 142 bottles of Bolirex cough syrup were put inside the original nylon carry bag, wrapped with white then packed it and marked as "D" as parent exhibit. The exhibits marked as D1, D2 & D were sealed with wax in presence of the witnesses. Hence, seized the above mentioned articles at 05:40 pm of 22/11/2019 and arrested the duo accused persons at 05:45 pm of 22/11/2019 by preparing formalities respectively.

Hence, the seized articles and arrested persons are brought at Lilong PS for further necessary action.
