With due respect, I have the honour to report that on 16/11/2019 at around 6:30 AM, the four individuals namely, (1) Salam (O) Mema Devi (63) year W/o (L) S. Shyamkesho Singh of Ukhongshang Mayai Leikai, PO - Yairipok, PS - Nongpok Sekmai (2) Thangjam (O) Pema Devi (60) years W/o Th. Rajen Singh of Ukhongshang Mayai Leikai, PO - Yairipok, PS - Nongpok Sekmai (3) Phuritsubun (O) Leirentombi Devi (62) years W/o Ph. Ram Singh of Salungpham Kangthokchao Mayai Leikai, PO- Wangjing, PS - Heirok (4) Sarangthem (O) Pemcha Devi (57) W/o. S. Brojendro Singh of Salungpham Kangthokchao Mayai Leikai, PO- Wangjing, PS - Heirok entered my paddy/agricultural land having Patta No. 353/984 (New) Dag No. 563, area- 0.1254 Hectare situated at Salungpham Lamyai Panthak without my consent and reaped the paddy which was growing there and stolen away the reaped paddy.
