Subject: Report

Sir,

I have the honour to report that today 06/11/2019, at 04.30 pm self along with my team of Kakching District Commando including Inspt. N. Tikendra Meetei, OC/CDO-Kakching led by Shri Lunkhomang Khongsai, MPS, Addl.SP(L/O), Kakching under the supervision of Smt Victoria Yengkhom, MPS, SP-KCG carried out frisking and checking at Khunuta Chingjin, Sora. In the course of frisking and checking, One motorist of Baj Pulsar-220 (black in colour) bearing registration No. unknown coming from Sora side towards Pallel in a very suspicious manner. While being stopped for verification, he however speed off towards Pallel side by throwing away a lady bag brown in colour mark as AVON alongside the road NH-102 near Khunuta Chingjin, Sora. The bike was chased upto Pallel Bazar but due to crowded area the unknown persons escape towards unknown location. Later the bag thrown by the unknown persons was opened in presence of Gazetted Police Officer Shri Lunkhomang Khongsai, MPS Addl-SP(LO)-KCG and witnesses present on the spot. Inside the lady bag, 15(Fifteen) Nos. of soap cases containing suspected heroin No.4 powder and one plastic polythene black in colour containing plastic packet mark as 'Ruchi Gold' suspected to be contraband Opium (Kani) were found. And also one AADHAAR Card in the name of T. Mangsat Haokip(19) S/o T. Khuplet Haokip of K. Savumpa Village, Chandel was found inside the front pocket of the said lady bag. Then weighed the contains of 15 soap cases containing suspected Heroin powder and plastic packet mark as 'Ruchi Gold' suspected to be contraband Opium (Kani) by using weighing scale in presence of witnesses and Gazetted Police Officer respectively on the spot. The contains of 15 soap cases were found weighing 14 grams each excluding the weight of the soap cases totaling 210 grams (14 gms x 15 gms). The weighed of plastic packet mark as 'Ruchi Gold' suspected to be contraband Opium (Kani) was found 980 gm. The 15 soap cases containing suspected Heroin No.4 powder and one plastic packet mark as 'Ruchi Gold' suspected to be contraband Opium (Kani) were then mark as "A, B, C, D, E, F, G, H, I, J, K, L, M, N, O and P as parent exhibits and put inside a paper envelope yellow in colour in presence of witnesses and Gazetted Police Officer for identification. Extracted 4 gms each of suspected Heroin No.4 powder from the parent exhibits "A, B, C, D, E, F, G, H, I, J, K, L, M, N, and O". Those are divided into two equal parts i.e. 2 gm each and separately put inside two plastic polythene and inserted inside two paper envelope yellow in colour separately which were properly packed and sealed by using wax and facsimile seal mark as 'A1, B1, C1, D1, E1, F1, G1, H1, I1, J1, K1, L1, M1, N1, and O1, and "A2, B2, C2, D2, E2, F2, G2, H2, I2, J2, K2, L2, M2, N2, and O2 respectively as original and duplicate samples. Further, extracted 10 gms of suspected contraband Opium(Kani) from parent exhibit 'P' and divided into two equal parts i.e. 5 gms each and separately put inside two plastic polythene and inserted inside two paper envelope brown in colour separately which were also packed and sealed and mark as 'P1' and 'P2' as original and duplicate samples.

The sealed samples and the parent's exhibits along with Aadhaar Card were then seized at Khunuta Chingjin, Sora by observing formalities in presence of gazetted police officer and witnesses. Therefore, the seized articles are handed over to you for further necessary action.
