I have the honour to report that today i.e. 26-11-2019 at around 7:00 am, received a reliable information from my own source that one unknown person is likely to exchange some contraband drugs inside the Tea Hotel of Mrs. Amina @ Painu Lamkang (50) w/o Md. Sakur located at Sora Bazar. On receipt of the information, I reduced the source report-information to writing and informed the matter to senior officer. Immediately, I along with my team of Kakching District commando comprising of women personnel led by Inspector N. Tikendra Meitei, OC/CDO Unit, District – Kakching under the Supervision of Shri N. Netrajit Singh, MPS, Addl. SP (Ops), Kakching rushed towards the spot and conducted house searched. During the searched, one lady was found to be in suspicious manner. On preliminary examination, she identified herself as Mrs. Amina @ Painu Lamkang (50) w/o Md. Sakur of Sora Bazar. So, she was given option to conduct body search by the women police personnel in presence of a Magistrate Gazetted Police Officer or independent witnesses. To which she desire to be searched by the women personnel in presence of Gazetted police officer. Hence, Gazette Police Officer Shri N. Netrajit Singh, MPS, Addl. SP (Ops), Kakching was requested to be present at the spot. Accordingly received her option statements and body search was conducted in the presence of Gazette Police Officer Shri N. Netrajit Singh, MPS, Addl. SP (Ops), Kakching. While body searched, one transparent plastic polythene containing 60 pieces of suspected SP (Spasmo Proxyvon) Capsules was found concealed inside her wear garments of the said lady. Hence, the above mentioned person was arrested from the spot at 7:40 am, observing formalities.

Then, marked the transparent plastic polythene containing 60 (sixty) pieces of suspected SP (Spasmo proxyvon) capsules as parent exhibits "A". Later, extracted 20 pieces/nos. of suspected SP (Spasmo proxyvon) capsules from the Parent Exhibits "A" and divided into two equal parts i.e 10 pieces each and put into two separate transparent plastic polythene which was further kept into two separated yellow envelope marked as "A1" and "A2" as Original samples and Duplicate samples respectively in presence of the Gazetted Police Officer Shri N. Netrajit Singh, MPS, Addl. SP (Ops), District-Kakching. The samples along with the parent exhibits were then packed and sealed by using wax and facsimile seal in presence of the witnesses and Gazetted Police Officer Shri N. Netrajit Singh, MPS, Addl. SP (Ops), Kakching.

The sealed samples and the parent exhibit were seized from the possession of Mrs. Amina @ Painu Lamkang (50) w/o Md. Sakur of Sora Bazar at 8:30 am under a formal seizure memo in presence of witnesses and Gazetted Police Officer Shri N. Netrajit Singh, MPS, Addl. SP (Ops), District-Kakching.

The arrested person along with the seized articles is handed over to you for further necessary action.
