I am to report that on 09/12/2019 at about 06.40 pm one R/E bullet bearing regd. no. MN06SC/2483 ridden by Ningthoukhongjam Sanatomba Singh 22yrs s/o N. Kumar Meitei of Langthabal Kunja Makha Leikai hit at the backside of bicycle which was ridden by my younger brother namely Md. Hassan 12yrs at Kaleikhong along NH-102.
