Subject: Report

Sir,

I have the honour to report that today i.e. 16/12/2019 at about 6:00 pm when I along with a Police team of Lilong PS led by Inspt. O. Ajit Singh, OC/LIL assisted by W/SI A. Satyabati Devi of Lilong PS was conducting frisking and checking at Lilong Arapti Lamkhai in connection with State Assembly Session which is commencing from 17/12/2019, one person was found walking in a very suspicious manner. When he saw our police team, he ran away towards Arapti side however our team chased and detained him near Arapti Bridge. At that point of time some members of LBADC (Lilong Bazaar Area Development Committee) and ALADA were also present there. In presence of PWs checked his body and found one transparent Polythene bag yellowing in colour containing some blue cylindrical capsules suspected to be SP capsules inside the right side pocket of his black leather jacket. On counting, it found 120 nos. of suspected SP capsules and on weighing, it weighed 86 grams. Then, took out 20 nos. of same suspected SP capsules and put inside two transparent plastics with ten nos. each and then again put inside two yellow envelopes. Then packed and sealed the two yellow envelopes and marked as "S1" and "S2" as original and duplicate exhibit samples. Then the remaining 100 nos. of suspected SP capsules were put inside the original yellow transparent polythene and put inside another yellow envelope. Then, packed and sealed the yellow envelope and marked as "S" as parent exhibit sample. Immediately I informed about the incident to my senior officer. On spot questioning, he identified himself as Md. Mayangmayum Amir Khan (38) S/O Md. Amuba @ Mazitullah of Chingkhani Maning and disclosed that on the same day i.e., 16/12/2019 at about 1:00 PM he contacted through his mobile handset (KACHAODA keypad) having mobile No. 6909683161 with one of his associates Mrs. Khusida from Lilong Ushoipokpi Tharaorok and purchased 140 (one hundred forty) SP capsules from her and out of these he sold out 20 (twenty) nos. of SP capsules to one of his customers, Md. Chaoba whose full particulars was not known to him. Then the packed and sealed drugs along with the mobile handset (keypad) were seized at the spot from the possession of the person at 6:40 pm. Then, arrested the person there at 6:45 pm by observing formal arrest memo.

As there was possibility of escaping his associates from their house, immediately without obtaining search warrant from the superior officer I along with the team of Lilong PS led by Inspt. O. Ajit Singh, OC Lilong PS assisted by W/SI A. Satyabati Devi of Lilong PS along with G-59 team led by Kh. Rambai, G-70 team led by W. Amarjit Singh, G-62 mobile, members of ALADA and LBADC under the supervision of SP/TBL rushed to the house of Mrs. Khusida at Lilong Ushoipokpi Tharaorok and cordoned the house being identified by the accused person. Then I called out all the members of the house and the accused person Md. Mayangmayum Amir Khan identified his associate Mrs. Khusida. On questioning she disclosed her full identity as Mrs. Khusida (27) W/o Md. Sajad of Khergaomakhaleikai A/P at her parental house at Lilong Ushoipokpi Tharaorok. Mrs. Khusida admitted that she has sold 140 (one hundred forty) nos. of SP capsules to her associate Md. Mayangmayum Amir Khan. With her consent searched the house and recovered one Samsung key pad mobile hand set with sim card bearing no. 6909574548 being found at her bed which was used in the illegal business of illegal drugs. On checking the call list of Mrs. Khusida's mobile handset, there was call log record of mobile No. 6909683161 on 16/12/2019. Accordingly, she was arrested at 07:10 pm and seized the Samsung key pad mobile hand set with sim card bearing no. 6909574548 from her possession observing formalities.
