Sir,

I am to report that today ie. 19/12/2019 at about 02:20 pm while self with OC/Lilong PS along with police party were discharging duties at Lilong bazar in c/w 12 hrs General Strike from 6:00am to 6 pm called by 5 (five) left parties CPI, CPI (M), CP (ML), RSP and Forward Block, Manipur Unit, suddenly some students numbering about 150/200 and ^{led by} some unknown adult persons who were the supporters of the General Strike came out at Lilong Aliya Lamkhai and proceeded towards Lilong bazar along the NH-102 by disturbing to the passers-by, commuters, plying vehicles and shouting different slogans against the recently passed Citizenship Amendment Act, 2019. Police intervened the unlawful assembly and managed to disperse it without any casualty in presence of SDO, Lilong. The bandh supports unlawfully assembled at the above place. They acted against the lawful order as well as affected peaceful governance of the lawfully established government of Manipur. They intimidated to general public in their free movement by imposing bandh. Thus committed mischief with their common intention. The act done by them was against the lawful direction of the Supreme Court of India

It is, therefore, reported to take up necessary legal action against the culprits.
