On 21/12/2019 at around 09:00 pm received a specific input from one of my trusted informer that one **Md. Aniyur Rahaman @ Themba (26) yrs. S/o (L) Md. Turab Ali** of Lilong Makha Leikai Salam Manung is selling illegal drugs like Spasmo Proxyvon Capsules at his house. Then, I reduced the same information into writing and sent a similar copy to SP Thoubal and also informed him about the information through mobile phone. Immediately two teams of Lilong PS led by myself assisted by SI. Md. Isha Khan of Lilong PS rushed to the said spot without obtaining search authorisation as there was great chance of escaping of offenders and concealing the illegal drugs. On reaching the house at 09:30 pm, our police team cordon the house very strictly and then I called out the family members of the house. In that one who identified himself as one **Md. Aniyur Rahaman @ Themba (26) yrs. S/o (L) Md. Turab Ali** of Lilong Makha Leikai Salam Manung came out of the house. Then I informed him that our police team would like to conduct search of his house. With his consent, our police team started to search his house in the presence of civil witnesses.

On searching, found one syntax (containing some household utensil) inside his bedroom and found one black colour polythene containing some articles inside. On opening the black colour polythene found one transparent light green colour plastic polythene containing blue colour cylindrical capsules suspected to be Spasmo Proxyvon capsules in loose form (not in strip form). On counting the suspected SP capsules found 139 nos. of suspected SP capsules weighing 99.2 grams.

Out of which, 20 nos. of the same capsules were taken out and put inside two yellow envelopes with 10 nos. of the capsules each, packed and sealed and marked as "A1" and "A2" respectively as original and duplicate sample exhibits respectively. And the remaining 119 nos. of the same capsules is put inside the original transparent light green colour plastic polythene and again put inside another yellow envelope packed and sealed and marked as "A" as Parent sample exhibits.

Then the packed and sealed yellow envelopes were seized from the unauthorised possession of **Md. Aniyur Rahaman @ Themba (26) yrs. S/o (L) Md. Turab Ali** of Lilong Makha Leikai Salam Manung on the spot at 09:55 pm in the presence of civil witnesses and also arrested the accused person on the spot 10:05 pm.

Hence all the packed and sealed drugs and the arrested accused person were brought to Lilong Police Station and registered a case under **FIR No. 130(12)2019, LIL PS U/S 21(b)/25 ND & PS Act.**
