Sir,

I, the undersigned have the honour to report that on 20/12/2019 at about 05:10 pm while my son namely Md. Rizwan aged about 10 yrs. was playing at a village playground near my locality with the neighbouring children, the above noted accused persons physically assaulted my child in view of a conflict among the children bringing at his house located at Lilong Haorou Hangamthabi. In that my relatives namely 1) Md. Khalilur Rahman aged about 40 yrs. S/o Md. Abdur Rahman of Lilong Haorou Hangamthabi, 2) Md. Shabir Shah aged about 26 yrs. S/o Md. Abdul Hei of -do-, 3) Md. Idrish Ali Shah aged about 18 yrs. S/o -do- and 4) Mrs. Wahida aged about 45 yrs. W/o Md. Abdul Hei of -do- went there to ask about the beating child. Moreover the above noted accused persons had also beaten seriously to them by holding deadly weapons like kitchen knife saying "why were you coming there and got out immediately". As a result of which, my son and relatives were seriously injured on their persons and evacuated the Noor Hospital, Lilong and later referred to the RIMS, Lamphelpat for further medical treatment.

So, it is therefore, requested to take up necessary legal action against the culprits at the earliest. The matter could not be reported in time while medical treatment of the injured persons.
