

Today i.e, 07/12/2019 at 8:50 pm received information that on the same day at about 8:40 Pm, one Kenbo bike B/R No.nil ridden by unknown rider which was coming from Khongjom side and proceeding towards Kakching side was dashed by unknown four wheeler vehicle driven by unknown driver which was coming from opposite direction along NH-102 at Irengband Lamkhai, Sora due to rash or negligent driving on the part of the unknown driver. The unknown vehicle was fled away from the spot by taking advantage of darkness. As a result of which the rider and one pillion rider of Kenbo bike sustained injuries on their persons and evacuated to Hospital for medical treatment. The Kenbo bike was partly damaged.

Hence, a suo-moto case under FIR No.94(12)2019 KCG-PS U/S 279/338/427 IPC has been registered for investigation.
