Subject: Report

Sir,

I have the honour to report that today i.e. 13-12-2019 at around 02:00 pm, received a reliable information from my own source that one Mayanglambam Rameshor Singh (35) s/o (L) M. Nepal Singh of Kakching Wairi Sabal Leikai Bamol Pareng is likely to exchange some contraband drugs inside the house of Shrimayum Rakesh Sharma (28) s/o (L) Shrimayum Dhanachandra Sharma located at Kakching Wari Sabal Leikai. On receipt of the information, I reduced the source report/information to writing and informed the matter to superior officer. Immediately, I along with my team of Kakching District Commando comprising of women police personnel led by Sub. Ksh. Prakash Singh, CDO- Unit Kakching under the Supervision of Shri N. Tikendras Meitei, OC/CDO Unit, District- Kakching and Shri N. Netrajit Singh, MPS, Addl. SP (Ops), Kakching rushed towards the spot and conducted house searched. During the searched, two persons were detained for verification. On verification, they identified themselves as (i) Shrimayum Rakesh Sharma (28) s/o (L) Shrimayum Dhanachandra Sharma of Kakching Wairi Sabal Leikai Bamol Pareng and (ii) Mayanglambam Rame shor Singh (35) s/o (L) M. Nepal Singh of Kakching Wairi Sabal Leikai Bamol Pareng. So, they were given option to conduct body search by the Police personnel in presence of a Magistrate/Gazetted Police Officer or independent witnesses. To which they desire to be searched by the Police personnel in presence of Gazetted police officer. Accordingly recorded their option statements and body search was conducted. While body searched, two plastic packets in which one transparent plastic polythene containing powdery substances suspected to be Heroin No.4 powder and another one black plastic packet containing 97 pieces/nos. of suspected WY Tablets was found concealed inside the right shoe of one Shrimayum Rakesh Sharma (28) s/o (L) Shrimayum Dhanachandra Sharma of Kakching Wari Sabal Leikai Bamol pareng. On weighing the contains of the transparent plastic polythene suspected to be Heroin No.4 powder in presence of the Gazetted Police Officer and the witnesses, the suspected Heroin No.4 powder was found to be weighing 14 grams including the weight of the plastic polythene. Hence, the above mentioned two persons were arrested from the spot at 02:30 pm under a formal seizure memo in presence of the Gazetted Police Officer and witnesses.

Then, extracted 8 (eight) grams of suspected Heroin No.4 Powder from the transparent plastic polythene containing 14 (fourteen) grams of suspected Heroin No.4 powder and divided into two equal parts i.e 4 (four) grams each into two separate transparent plastic polythene which was further put inside two separated brown envelope papers marked as "A1" and "A2" as Original samples and Duplicate samples respectively in presence of the Gazetted Police Officer, Shri N. Netrajit Singh, MPS, Addl. SP (Ops), District-Kakching. Then, the remaining exhibit i.e 6 grams of suspected Heroin No.4 powder contained in a transparent

Further, extracted 10 (Ten) nos./pieces of suspected contraband WY Tablets from the black plastic packet and divided into two equal parts i.e 5 (five) nos./pieces each into two separate transparent plastic polythene and put inside two separate brown envelope papers marked as "B1" and "B2" as Original samples and Duplicate samples respectively. The remaining 87 nos./pieces of suspected contraband WY tablets contained in a black plastic was put inside one brown envelope paper and marked as "B " as Parent Exhibit. The samples along with the parent exhibits were then packed and sealed by using wax and facsimile seal in presence of the witnesses and Gazetted Police Officer Shri N. Netrajit Singh, MPS, Addl. SP (Ops), Kakching.

The sealed samples and the parent exhibit were seized from the possession of Shrimayum Rakesh Sharma (28) s/o (L) Shrimayum Dhanachandra Sharma located at Kakching Wari Sabal Leikai at 3:00 pm under a formal seizure memo in presence of witnesses and Gazetted Police Officer Shri N. Netrajit Singh, MPS, Addl. SP (Ops), District-Kakching.

The arrested person along with the seized articles is handed over to you for further necessary legal action.
