Subject: Report



Sir,

I have the honour to report that today, i.e. on 16/12/2019 at about 11:30 am, 39 Assam Rifles shared a reliable information to me that one Thokchom (O) Yengkhom Sharmila Devi (45) W/o Th. Deepak Singh of Kakching Ningthou Leikai AOC Pareng possessing a huge quantity of illegal drugs for his illegal selling to the local drug addicts. On receipt of the information, I reduced the source report/information to writing and informed the matter to Addl. SP (Ops), Kakching and immediately a teams of CDO Kakching, comprising self along with women police personnel, led by Inspector N. Tikendra Meetei, O/C CDO, Kakching, all wearing uniform and civil dress, under the supervision of Shri N. Netrajit Singh, MPS, Addl SP (Ops), Kakching rushed towards Kakching Ningthou Leikai AOC Pareng. On reaching at the house of Thokchom (O) Yengkhom Sharmila Devi (45) all the family members (males and females) were called out and on asking their identities one person identified himself as Thokchom (O) Yengkhom Sharmila Devi (45) W/o Th. Deepak Singh of Kakching Ningthou Leikai AOC Pareng. The individual was detained and conducted search inside her room and on further checking at the neighbor house of Yengkhom Nanao Singh of Kakching Ningthou Leikai a white colour plastic sack suspected to be contraband drugs was found inside the kitchen of Yengkhom Nanao Singh of Kakching Ningthou Leikai which was said to be kept and conceal by Thokchom (O) Yengkhom Sharmila herself. On opening and checking of the white colour plastic sack found containing 214 (two hundred and fourteen) bottles of MACODIN Syrup containing Codeine Phosphate and Chlorpheniramine Maleate Surup (each bottle contained 10 mgs of Codeine Phosphate and 4 mgs of Chlorpheniramine Maleate Surup). Accordingly, the said illegal drugs were seized from the production and possession of Thokchom (O) Yengkhom Sharmila Devi (45) W/o Th. Deepak Singh of Kakching Ningthou Leikai AOC Pareng by preparing a seizure memo in presence of independent witnesses at 2:30 pm. Out of the 214 bottles, 2 bottles were taken out and put 1 each inside two yellow colour envelopes as original and duplicate samples and marked as "A" and "B" respectively and the remaining 212 bottles were put in the plastic sack and wrap in white cloth as parent exhibit and marked as "C". The parent exhibits and samples exhibit were packed and sealed in presence of independence witness and Gazette officer Shri N. Netrajit Singh, MPS, Addl SP (Ops), Kakching.

Therefore, the accused Thokchom (O) Yengkhom Sharmila Devi (45) was arrested on the spot at 02:50 pm.

On further questioning, Thokchom (O) Yengkhom Sharmila Devi (45) stated that the MACODIN Syrup containing Codeine Phosphate and Chlorpheniramine Maleate Surup were delivered by one Shyam Meetei (37) of Imphal for selling to interested persons.

Therefore, the arrested person along with the seized articles is handed over to you for taking up further necessary legal action.
