Subject: Request for proper investigation under unlawful Activities Prevention Amendment Act, UA(P)A. Act of Thokchom (O) Yengkhom Sharmila Devi (45) W/o Th. Deepak Singh of Kakching Ningthou Leikai AOC Pareng who is still in the custody of Case FIR.NO.98(12)2019 KCG-PS U/s. 21(a) & 29 ND & PS Act

Sir,

In submitting herewith the following report I, have the honour to state that on 16-12-2019 at 04.10 pm, Ksh. Shantikumar Singh, Hav.No.411820, 4th IRB attached to CDO-Unit, Kakching reported to OC/KCG-PS to the effect that on received of reliable information that one Thokchom (O) Yengkhom Sharmila Devi (45) W/o Th. Deepak Singh of Kakching Ningthou Leikai AOC Pareng was in possession of huge quantity of illegal drugs for trafficking to the local drug addicts. On receipt of the information, and after informing the matter to Addl. SP (Ops), Kakching, a team of CDO-Unit Kakching, along with women police personnel, led by Inspector N. Tikendra Meetei, OC/CDO-Kakching under the supervision of Shri N. Netrajit Singh, MPS, Addl. SP (Ops), Kakching rushed towards Kakching Ningthou Leikai AOC Pareng and conducted search inside her room and on further checking at the neighbor house of Yengkhom Nanao Singh of Kakching Ningthou Leikai, a white colour plastic sack suspected to be contraband drugs was found inside the kitchen of Yengkhom Nanao Singh of Kakching Ningthou Leikai which was said to be kept and conceal by her. On opening and checking of the white colour plastic sack, it was found containing 214 (two hundred and fourteen) bottles of MACODIN Syrup containing Codeine Phosphate and Chlorpheniramine Maleate Syrup (each bottle contained 10 mgs of Codeine Phosphate and 4 mgs of Chlorpheniramine Maleate Syrup). Accordingly, the illegal contraband drugs were seized from the production and possession of Thokchom (O) Yengkhom Sharmila Devi (45) W/o Th. Deepak Singh of Kakching Ningthou Leikai AOC Pareng by preparing a seizure memo in presence of independent witnesses at 2:30 pm. The arrested women with the seized article was handed over to this PS for taking up necessary action. Hence is the case.

In the course of investigation, the arrested accused person Thokchom (O) Yengkhom Sharmila Devi (45) W/o Th. Deepak Singh of Kakching Ningthou Leikai AOC Pareng was remanded into police custody for a period of 5(five) days w.e.f 17/12/2019 to 21-12-2019 with the order passed by the Hon'ble court of Special Judge ND & PS, Thoubal dated 17-12-2019.

On interrogation of the accused Thokchom (O) Yengkhom Sharmila Devi (45) W/o Th. Deepak Singh of Kakching Ningthou Leikai AOC Pareng and investigation of the case, it is learnt that she was the over ground member of KYKL and nexus with the banned outlaw KYKL organization working under the command of self style finance section Chingkhel for extortion and raising fund for the KYKL organization to the general public of Kakching area in the month of June and July 2018. She assisted in the work of KYKL organization.

It is therefore, requested to kindly registered a regular case under UA(P)A. Act for proper investigation.
