Sir,

I have the honour to report that today i.e. 02/01/2020 at 4:00 pm received a specific information that some unknown habitual vehicle lifters have gathered at Lilong Atao Car Wash area near Lilong Oil Pump with an ulterior motive for selling/disposal of stolen vehicles. Acting on the information, I along with Police Party assisted by ASI Sera Khan of Lilong PS under the supervision of SP/TBL & Addl. SP (L&O)/TBL immediately rushed to the said area and conducted search. At about 4:10 pm, we saw that one unknown person was trying to flee away with one Royal Enfield Bullet without registration number from Atao Car Wash area in a suspicious manner. As suspicious, the unknown individual was detained and on verification, he disclosed himself as Md. Amir Khan (27) S/o Md. Nasir Khan of Lilong Haoreibi Sambrukhong Mamei. On asking, he produced one RC book of bearing Registration No. HR26DI-9852 having Chassis No. ME3U3S5C1JA598174 & Engine No. U3S5C1JA664484, issued by Registering Authority, Gurgaon, Haryana. On physical inspection, the Royal Enfield Bullet without registration number bears Chassis No. ME3U3S5C1JA398174 & Engine No. U3S5C1JA664818 which is not matched with the RC Book produced by him. On preliminary examination, he disclosed that the Royal Enfield Bullet is stolen vehicle and it was stolen by one of his associates namely Md. Akhan (38) S/o Md. Majit of Lilong Makha Leikai. Md. Akhan handed over the stolen Royal Enfield Bullet to him for disposal. Hence, he was arrested at 4:35 pm and seized the Royal Enfield Bullet along with the RC book at 4:40 pm from the spot by observing formalities.


It is therefore, the arrested person along with the seized articles is handed over to you for taking further necessary action.
