

Subject:- Report.

Sir,

I have the honour to report that on 03/01/2020 at about 11:40 pm while I was performing my normal duty at Lilong Bazar received reliable information that one drug peddler namely Md. Nasir Hussain (28) yrs, S/o. Md. Abdul Halim of Lilong Uku Mathak near Lilong Oil Pump is selling illegal drugs Heroin No. 4 at his house and kept concealed at his house. Accordingly, I recorded the information in writing and a copy of the same was furnished to my senior officer for information. Quickly, I along with my team rushed to the said place without obtaining search authorization as there was great chance of escape of the offender and concealing the drug. I also called upon some volunteers of Yumkhaiphom Athletic Development Association (YADA) and cordoned the house. On reaching the house of Md. Nasir Hussain, I called out the members of that house, after that I asked for the owner of that house and one person namely Md. Nasir Hussain (28) yrs, S/o. Md. Abdul Halim of Lilong Uku Mathak said he is the owner of that house. Then I asked his opinion to search/check the house in presence of a Magistrate or a Gazetted Officer. In that he opined to search in presence of civil witnesses. Accordingly in presence of civil witness checked the house. On searching the house, found black plastic polythene from the Almirah. On opening the said black plastic polythene bag, found one red in colour soop cap containing brown colour powder suspected to be Heroin No. 4. So he was arrested from the spot at 00:40 am of 04/01/2020.

On weighing the suspected Heroin No. 4 powder, it weighed 11.2 (eleven point two) grams. Out of 11.2 grams, 2 (two) grams have been taken out and packed and sealed in two yellow envelopes each marked as "H1" & "H2" as original and duplicate sample respectively and the remaining 9.2 grams of the suspected Heroin No. 4 powder was packed and sealed and marked as "H" as parent sample.

Hence the packed and sealed drugs were seized from the possession of Md. Nasir Hussain (28) yrs, S/o. Md. Abdul Halim of Lilong Uku Mathak near Lilong Oil Pump by observing formalities at 00:50 am of 04/01/2020. So, the arrested person and seized articles mentioned above are brought and handed over to Lilong Police Station for further necessary legal action.
