Sub: - Report.

Sir,

I have the honour to report that on 14/01/2020 at about 10:40 am while I was at Lilong Police Station received reliable information that one drug peddler namely Md. Aziz @ Abungo (20) S/o Abdul Hashim of Lilong Boroï Makhong is selling illegal drugs i.e. illegal cough syrups, at his house and some quantities of the said drugs are still kept concealed at his house. Accordingly, I recorded the information in writing and a copy of the same was furnished to my senior officer for information. Immediately, I along with Police Party rushed to the said place without obtaining search authorization as there was great chance of escaping the offender and concealing the drug. On reaching at his house at about 11:00 am of the day, we called out family members of the house. When called upon, one person identified himself as Md. Aziz @ Abungo (20) S/o Abdul Hashim of Lilong Boroï Makhong came out of the house and disclosed himself as owner of the house. Then, I informed him that we have reason to believe that he had sold illegal cough syrups and some quantities of drug is still kept concealed at his house and we would like to conduct house search. Thereafter, I requested two persons available there to be witness while conducting some legal formalities and they also agreed. In presence of the witness, I conducted house search. On searching in the kitchen, found 11 bottles of CodyLate cough syrup (100 ml each) kept concealed inside the furnace (Funga/Leirang). On checking, each bottle of CodyLate cough syrup contains 10 mg of codeine phosphate per 5 ml each (as per composition) which is a contravened substance under ND&PS Act. On calculation/weighing, one bottle of cough syrup contained $10 \times 20 = 200$ mg of codeine (as per composition), altogether contained $200 \times 11 = 2,200$ mg of codeine phosphate. Then, I extracted two bottles of CodyLate cough syrup, put inside the two yellow envelopes separately, packed and marked as "C1" & "C2" as original & duplicate representative samples respectively. The remaining 9 bottles of CodyLate cough syrup were put inside a yellow envelop, packed it and marked as "C" as parent exhibit. The samples marked as C1, C2 & C were sealed with wax in presence of the witnesses. On examination, it is learnt that he is a regular and habitual illegal drug seller. Earlier, he was arrested for committing similar offence i.e. selling of illegal cough syrups and now he is on bail. It refers to case FIR No. 106(11)2019 LIL-PS U/s 9A/25A/21(b)/21(c)/25/29 ND&PS Act. Hence, he was arrested at 12:30 pm and seized the above mentioned articles at 12:35 pm of 14/01/2020 by observing formalities.

Hence, the arrested person along with the seized articles is handed over to you further necessary action.
