

Today i.e. 15/01/2020 at around 07:30 pm, received specific information that one **Md. Imtias (35)** S/O (L) Md. Ahamed Ali of Lilong Haoreibi Mayai Leikai is selling illegal Cough Syrup bottles at his house. Immediately, I reduced the said information into writing and sent a similar copy to SP Thoubal. Also informed the volunteers of ANJUMAN and ALADA through mobile phone to be witnesses. Then I along with my team and volunteers of ANJUMAN & ALADA rushed to the said house at Lilong Haoreibi Mayai Leikai. On reaching the house, the police team cordon the house very strictly and called out the family members of the house in that Md. Imtias came out of the house. Then I informed him that our police team would like to conduct search of his house. With his consent, our police team along with the volunteers of ANJUMAN and ALADA searched the house and found one cartoon box containing 71 nos. of Cough Syrup bottles marked as "Swirex" containing 10 mg of codeine phosphate per 5 ml. Out of which, 4 bottles were taken out and put inside two yellow envelopes with 2 bottles each, packed and sealed and marked as "C1" and "C2" as Original and Duplicate sample exhibit respectively. Similarly the remaining 67 nos. of bottles are put inside the original cartoon box wrapped with white cloth packed and sealed and marked as "C" as Parent sample exhibit. On further searching his room found 3 nos. of mobile phones i.e. one Samsung J7, one Samsung Duos Keypad mobile and one Vivo mobile phone.

Then the packed and sealed drugs along with the 3 mobile phones were seized from the possession of **Md. Imtias (35)** S/O (L) Md. Ahamed Ali of Lilong Haoreibi Mayai Leikai in the presence of witnesses by observing all the necessary formalities at 08:30 pm and subsequently arrested him at 08:40 pm.

Hence the arrested person along with the seized articles were brought to Lilong PS for necessary legal actions.
