Subject: Report.

I have the honour to state that today i.e. 22/01/2020 at about 12:15 pm while I was at Lilong PS received reliable information that one drug peddler namely Mrs. Mumtaz @ Abem (28) W/o Md. Firoj of Lilong Haoreibi Makha Leikai Lairaba Khong A/P staying at Lilong Haoreibi Awang Leikai is selling illegal drug i.e. Heroin No.4 (opium derivative) at her house (Lilong Haoreibi Awang Leikai) and some quantities of the said drug is still kept concealed at her house at located Lilong Haoreibi Awang Leikai. Accordingly, I recorded the information in writing and a copy of the same was furnished to my senior officer for information. Immediately, I along with my Police team including W/PCs of Lilong PS rushed to the said place without obtaining search authorization as there was great chance of escaping the offender and concealing the drug. I also called upon some volunteers of All Lilong Anti Drug Association (ALADA) at the place so as to witness the search/raid. On reaching at the house at about 12:40 pm, one lady hurriedly ran out of the house in a suspicious manner and entered inside of a neighbouring house. Without any delay, our Police teams cordoned the house which she entered. When called upon, the lady who ran inside the house came out and identified herself as Mrs. Mumtaz @ Abem (28) W/o Md. Firoj of Lilong Haoreibi Makha Leikai Lairaba Khong A/P staying at Lilong Haoreibi Awang Leikai. When asked, she disclosed the house which she entered was the house of her elder brother namely Md. Gyasuddin S/o Md. Qutub located at Lilong Haoreibi Awang Leikai. Then, I informed her that I have reason to believe that she had sold Heroin No.4 and some quantities of drug is still kept concealed at her house and I would like to conduct house search as well as body search. I informed her verbally as well as in writing about her legal right to be search her body before a Magistrate or Gazetted Officer. In that, she told us not to take her before a Magistrate or a Gazetted Officer to conduct her body search. Subsequently, she took out one transparent plastic bottle containing some yellowish colour powder and dropped the same on the ground disclosing that the transparent plastic bottle contains 6 grams of Heroin No.4 and she was trying to conceal it. I requested two volunteers of ALADA to be witnessed while opening the transparent plastic bottle. On opening the transparent plastic bottle, found some yellowish powder substances suspected to be Heroin No. 4. On weighing the powder substance, it weight 6.14 grams excluding the weight of the container. Out of 6.14 grams of suspected Heroin No. 4, extracted 2 grams suspected Heroin No. 4, put one gram each inside the two small transparent polythene and packed. The packed two small transparent polythene containing one gram of each suspected Heroin No. 4 was again inserted inside two yellow envelops and marked as H1 & H2 as original & duplicate sample respectively. The remaining 4.14 grams of suspected Heroin No. 4 was put inside the original transparent plastic bottle, put inside a yellow envelop and marked as H as parent sample. The exhibits marked as H, H1 & H2 were packed and sealed in presence of witnesses. Hence, she was arrested at 1.30 pm of the day and seized the detected drugs from her possession at 1:35 pm of the day and brought at Lilong PS and handed over to you for further necessary steps.
