Subject: - Report

Sir,

I have the honour to report that today i.e. 23/01/2020 at around 09:00 am, while I along with my police team were conducting frisking and checking of the suspected persons at the IVR of Lilong Arapti as a preventive measure of the upcoming 26<sup>th</sup> January 2020. In that one person came on a Honda Dio blue and black in colour. Then our police team detained him for verification. On verification he identified himself as one Sapam Bailot Singh (30) S/O S. Romio Singh of Haobam Marak Ngangom Leikai. Then I checked the inside of his vehicle and found one blue colour polythene containing some blue colour cylindrical capsules suspected to be SP causes, on the upper side of the engine of the vehicle. On counting the blue colour cylindrical capsules found 330 (three hundred and thirty) nos. of suspected SP capsules. Out of which 10 nos. of the same capsules were taken out and put inside two yellow envelopes with 5 nos. each, packed and sealed and marked as "S1" and "S2" as Original and Duplicate sample exhibits respectively. And the remaining 320 nos. of the same SP capsules were put inside the blue colour plastic polythene and again put inside another yellow envelope packed and sealed and marked as "S" as Parent sample exhibit. When inquired, he stated that he is an illegal drug seller as well as drug user.

Then the said individual namely Sapam Bailot Singh (30) S/O S. Romio Singh of Haobam Marak Ngangom Leikai was arrested on the spot at 09:45 am and seized the packed and sealed drugs and the Honda Dio blue and black in colour, bearing registration no. MN 01D 4695, engine no. JF111-4006621 and chassis no. ME-4J118AA8006406 from his unauthorized possession at 09:55 am in the presence of civil witness. Therefore, the seized articles and the arrested person were brought to Lilong PS and handed over to you for further necessary legal actions.
