Sir,

I have the honour to report that on 27/01/2020 at around 06.00 am while I was taking rest on my bed, my son namely **Md. Abdul Rajak** aged about 32 yrs was entered my room and assaulted me by punching and kicking by demanding of huge amount of money as well as his land share. In due effect I suddenly fled away from the area for safety of my life and chased me. On seeing the scene, I shouted for help but fall slipped within a short distance. Immediately, some neighbors including my brother rushed and overpowered my son and rescued me. As a result of which, I sustained injury on my persons and evacuated me to the Noor Hospital, Lilong for medical treatment.


It is therefore requested kindly to take up necessary legal action against the habitually crime offender Md. Abdul Rajak.
