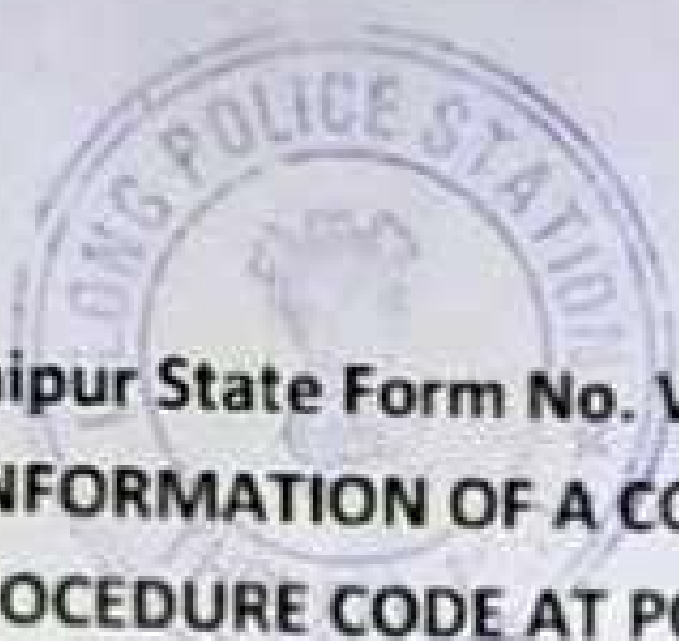

On 07/02/2020 at around 10:50 pm, received specific information from my personal source person that two persons namely Md. Minhajuddin 29yrs, S/o. (L)Md. Karimuddin of Lilong Lou Tara and his younger brother Md. Wahajuddin @ Waha25yrs are selling illegal drugs at their house at Lilong Lou Tara. Accordingly, the version of the informer is recorded in writing and a similar copy of the same has been forwarded to SP/Thoubal for information. Immediately, I along with Police Party assisted by SI Md. Wakibuddin of Lilong PS rushed to the said place without obtaining search authorization as there was great chance of escaping of the offender and concealing the drug. On reaching the house the police team strictly cordoned the said house and informed the volunteers of ANJUMAN to be witnesses while conducting search and other formalities. Then I called out the owner of the house and in that, six persons came out of the house. Among them, my source person identified Md. Minhajuddin 29 yrs and his brother Md. Wahajuddin @ Waha 25yrs. Then I informed Md. Minhajuddin that I would like to conduct search of his house in the presence of civil witnesses. With his consent, the said house was searched in presence of the civil witnesses. On searching, found one green colour carry bag inside one almirah placed at the bed room of Md. Minhajuddin. On opening the said carry bag found 94 (ninety four) nos. of "MMD" Cough Syrup bottles (100ml each) and 9 (nine) nos. of "Bolirex" Cough Syrup bottles (100 ml each). On checking, each bottle of "MMD" and "Bolirex" Cough Syrup found containing 10 mg of codeine phosphate per 5 ml each (as per composition). On calculation/weighing, one bottle of "MMD" cough syrup contained $10 \times 20 = 200$ mg of codeine phosphate (as per composition), altogether $200 \times 94 = 18,800$ mg of codeine phosphate for "MMD" cough syrup and one bottle of "Bolirex" contained $10 \times 20 = 200$ mg of codeine phosphate (as per composition), altogether $200 \times 9 = 1,800$ mg of codeine phosphate for "Bolirex" cough syrup. On questioning about the illegal cough syrup bottles, Md. Minhajuddin stated that the detected illegal cough syrups belonged to him and his younger brother Md. Wahajuddin @ Waha. They collectively sell illegal cough syrups for their wrongful gain. Then, in presence of the witnesses, I seized the illegal cough syrup bottles from the possession of Md. Minhajuddin 29yrs, S/o. (L) Md. Karimuddin of Lilong Lou Tara at 11:30 pm of the day and arrested Md. Minhajuddin at 11:40 pm of the day. Further, I arrested his younger brother Md. Wahajuddin at 11:45 pm of the date.

Hence, a suo motto case under **FIR No. 15(02) 2020 LIL-PS U/S 21(b)/29 ND & PS Act** has been registered for investigation.
