Sub: Report.

Sir,

I have the honour to report that on 14/02/2020 at around 8:30 pm, while I was performing duty at Lilong Bazar, received specific information from my personal source person that one person **namely Md. Zakir aged about 22 yrs, S/o. Md. Sanayai of Lilong Turel Ahanbi Boro Makhong** is selling illegal cough syrups at his house. Accordingly, the version of the informer is recorded in writing and a similar copy of the same has been forwarded to SP/Thoubal for information. I telephonically informed Shri H. Johnny Sharma, MPS (SDPO/TBL) about the source information. I also requested some volunteers of All Lilong Anti Drug Association (ALADA) to witness the raid/search. Thereafter, a combined team of District Police Thoubal led by Shri H. Johnny Sharma, MPS (SDPO/TBL) assisted by self along with my team and SI Md. Isha Khan of Lilong PS under the overall supervision of Shri Dr. S. Ibomcha Singh, Superintendent of Police, Thoubal rushed to the said place without obtaining search authorization as there was great chance of escaping of the offender and concealing the drug. On seeing the Police Teams, the drug peddler Md. Zakir fled away from his house. Police party chased him but he managed to escape by taking advantages of darkness. Then, in presence of SDPO/TBL and civil witnesses, the said house was searched. On searching of his bed room, found one green colour gunny bag (sack) and one yellow colour gunny bag (sack) placed at the beneath of his (Md. Zakir) bed in a suspicious manner. In presence of witnesses, the green colour gunny bag and yellow colour gunny bag were opened. On opening of green colour gunny bag (sack), found containing **300 (three hundred) nos. of "MMD" Cough Syrup bottles (100ml each)**. On checking, each bottle of "MMD" Cough Syrup found containing 10 mg of codeine phosphate per 5 ml each (as per composition). On calculation/weighing, one bottle of "MMD" cough syrup contained $10 \times 20 = 200$ mg of codeine phosphate (as per composition), altogether $200 \times 300 = 60,000$ mg (60 gm) of codeine phosphate. On opening of yellow colour gunny bag (sack), found **120 (one hundred twenty) nos. of "MMD" Cough Syrup bottles (100 ml each) contained inside a carton box**. On checking, each bottle of "MMD" Cough Syrup found containing 10 mg of codeine phosphate per 5 ml each (as per composition). On calculation/weighing, one bottle of "MMD" cough syrup contained $10 \times 20 = 200$ mg of codeine phosphate (as per composition), altogether $200 \times 120 = 24,000$ mg (24 gm) of codeine phosphate. Then, in presence of the witnesses, I seized the illegal cough syrup bottles from the house (bed room) of Md. Zakir aged about 22 yrs, S/o. Md. Sanayai of Lilong Turel Ahanbi Boro Makhong at 9:20 pm of the day by preparing formalities.

It is therefore, the above noted seized illegal cough syrup bottles are handed over to you for taking necessary legal action.
