Sir,

I have the honour to report that on 25/02/2020 at about 07:00 pm received a secret information from my source that one Meraimayum Amir Hussain @ Ithem (24) S/O Md Hessamuddin of Lilong Awang Leikai is selling illegal drugs and now according to source report he is expected to deal a big consignment of illegal drugs at the said area. Accordingly I have reduced the source report in written and submitted to my immediate senior officer. Immediately two police teams of Lilong PS led by myself and assisted by ASI Md Ramjan Mubarak of LIL-PS along with members of Civil Association ALADA, ANJUMAN and my source person rushed to the area without obtaining search authorization as there is chances of escaping the culprit and concealing the illegal drugs. On reaching the informed house, our police team cordoned the house and call out the members of the house. On that one person came out and who identified himself as Meraimayum Amir Hussain @ Ithem (24) S/O Md Hessamuddin. Then I informed him that our police team would like to conduct search of his house, then conducted house search with my personnel in presence of him and witnesses. During the search, our police team detected a sky-blue colour carry bag and another white carry bag at the corner of his bed room near the bed. In presence of the witnesses, the sky blue colour carry bag and the white colour carry bag were opened. On opening the said carry bag, found 92 nos. of Cough Syrup bottles marked as "SIOREX" (100ml each) were found. On checking each bottles of Cough Syrup found containing 10 mg of Codeine Phosphate per 5 ml each (as per composition). On calculation/weighing one bottle of cough syrup contained $10 \times 20 = 200$ mg of Codeine phosphate, altogether $200 \times 92 = 18400$ mg i.e. 18.4 gram of Codeine Phosphate.

Again on opening the white carry bag found 50 nos. of Cough Syrup bottles marked as "RECHARGE" (100ml each). On checking each bottles of Cough Syrup found containing 10 mg of Codeine Phosphate per 5 ml each (as per composition). On calculation/weighing one bottle of cough syrup contained $10 \times 20 = 200$ mg of Codeine phosphate, altogether $200 \times 50 = 10000$ mg i.e. 10 gram of Codeine Phosphate. Altogether, found $(18.4 + 10) = 28.4$ grams of Codeine Phosphate. Then in the presence of the witnesses, I seized the illegal cough syrup bottles from unauthorized possession of Meraimayum Amir Hussain @ Ithem (24) S/O Md Hessam of Lilong Awang Leikai at 08:30 pm by observing formalities and arrested the accused person namely Meraimayum Amir Hussain @ Ithem (24) S/O Md Hessamuddin of Lilong Awang Leikai at 08:35 pm. Then I immediately inform my senior officers about the incident.

Therefore, the seized illegal drugs along with the arrested person is handed over to you for necessary legal actions.
