Subject :- Report.

Sir,

I have the honour to report that today i.e. 29/02/2020 at about 08:10 p.m. I along with my CDO team, Thoubal conducted frisking and checking at Ushoipokpi near Tamyai While conducting frisking and checking, one passenger auto rickshaw with passengers was coming from Lilong Dam towards Lilong Bazar side. We stopped the said auto rickshaw for checking of the passengers. In that one black polythene bag suspected to be contraband drugs was detected from an unknown youth who was later identified as Moijingmayum Farish Khan @ Thoiba (21) S/o MM. Siraj Ahamed of Moijing Awang Leikai.

On preliminary verification, he disclosed that he along with Wangmamayum Imtiyas (19) S/o Wangmamayum Azad of Lilong Heinou Makhong were coming from Mina Bazar towards Lilong Bazar by a passenger auto rickshaw for selling the drugs. On his body search, one mobile handset of Lenovo having Jio SIM card bearing mobile No. 9366950563 was detected from his possession. On further checking the black polythene bag, we detected 5(five) boxes of Halonitra-10 tablets containing 10(ten) strips of Halonitra-10 tablets (10 tablets per strip) each per box. On checking the Halonitra-10 tablets, it contains Nitrazepam I.P (as per composition) and all strips are of similar shape, size, colour and texture. On weighing, one strip of Halonitra-10 tablet weighed 7.2 gram i.e. altogether $7.2 \times 50 = 360$ gms. On spot verification, he disclosed that he received the drugs from one Moijingmayum Ajit (28) s/o (L) MM. Nijamuddin of Moijing Wangmataba. Finally, all the exhibits were seized by preparing a formal seizure memo at 08:45 p.m. from the possession of Moijingmayum Farish Khan @ Thoiba (21) s/o MM. Siraj Ahamed of Moijing Awang Leikai. Arrested the accused persons namely Moijingmayum Farish Khan @ Thoiba (21) s/o MM. Siraj Ahamed of Moijing Awang Leikai and Wangmamayum Imtiyas (19) s/o Wangmamayum Azad of Lilong Heinou Makhong from Ushoipokpi Tamyai by preparing formal arrest memos at 09:10 p.m. and 09:15 p.m. respectively. Then, I obtained the signature of the arrestees and witnesses on the seizure memo, arrest memos in which I myself also put signature on the same.

In accordance with the direction of Hon'ble Supreme Court in the case Union of India Vs Mohanlal and Ors, 2016 Cril. Appeal No. 652 of 2012, the necessary procedure shall be adhered to in the presence of Magistrate.

The arrested persons along with the seized articles have been handed over to you for taking further necessary legal action.
