He has stolen almost all the household items from home and disposed off to undisclosed destinations. He has damaged the house we are living in. He frequently manhandles me. Yesterday, 29th Feb., 2020 at about 7.00 P.M., he beat me up for not giving him money. I was lucky to have been saved by the neighbours who rushed in to my house after hearing the loud noise made by him and took me to the nearby hospital. I am really scared of his violent behaviours.

I therefore, request you earnestly to kindly do me a favour by picking him up and booking him under law so that I may be saved from his cruel hands and I shall remain ever grateful to you for your act of kindness and necessary immediate action.
