
I am submitting a complaint regarding the violent attack by the candidates of the HSLCE 2020 at the Lilong Higher Secondary Madrassa Centre today, the 5th March 2020.

After the last/final bell of the examination, the candidates suddenly attacked the Exam Centre with stones and other available materials. The damages caused by the violent attack may be mentioned as under :-

1. Suzuki Celereo Car – (one Car)

3. Suzuki Van (Two Vans)

5. Doors and windows, Desks and Benches, White Board etc.
6. More than twenty students have collapsed, five students injured and one teacher, named R.K. Milan Singh, Lecturer of Economics was seriously injured on the head and the face by the stones hurled by the candidates and hospitalized at the Lilong PHC, Thoubal District, Manipur.
