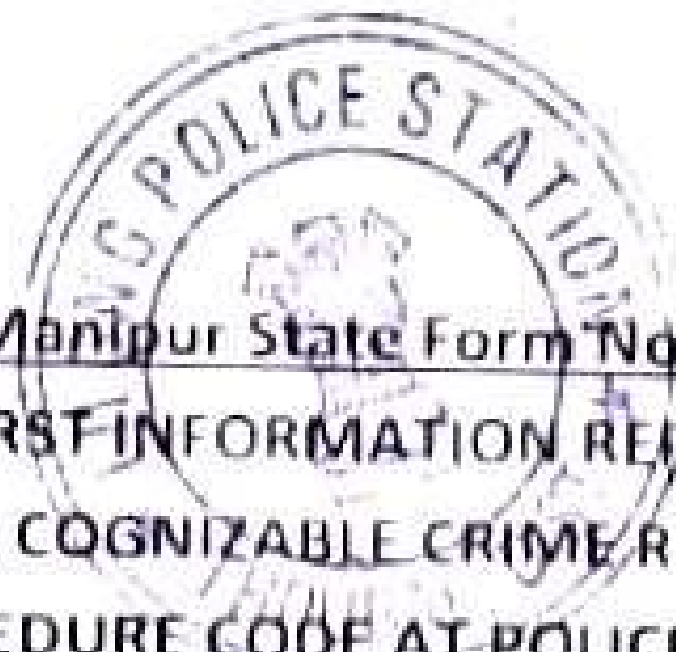

Sub: - Report.

Sir,

I have the honour to report that on 16/03/2020 at around 08:00 pm received a specific input from one of my trusted informer that one **Aribam Akhtar Huissain (20)** yrs. S/o Md. Sanayai & Ruhina of Lilong Turel Ahanbi Khongnangkhong Mathak is selling illegal drugs like Spas Primevon (Tramadol) Capsules and illegal Cough Syrup bottles at his mother's parental house located at Lilong Lou Tara. Then, I reduced the same information into writing and sent a similar copy to SP, Thoubal and also gave telephonic information to SP, Thoubal. Immediately two teams of Lilong PS led by Inspt. O. Ajit Singh, OC, Lilong PS assisted by me (SI Md. Isha Khan of LIL-PS) along with the some members of All Lilong Anti Drug Association (ALADA), Lilong rushed to the said spot i.e. at the house parental house of **Aribam Akhtar Huissain's** mother located at Lilong Lou Tara. On reaching the house at 08:30 pm, our police team cordon the house very strictly and then I called out the family members of the house. In that, one person who identified himself as one **Aribam Akhtar Huissain (20)** yrs. S/o Md. Sanayai of Lilong Turel Ahanbi Khongnangkhong Mathak came out of the house. He also disclosed that the house was his mother's parental house and he has been staying there since one month. Then I informed him that I have reason to belief that he has been selling illegal drugs like Spas Primevon Capsules and illegal Cough Syrup bottles at the said house and would like to conduct search of the house. With his consent, our police team started to search his house in the presence of civil witnesses.

While searching at his bed room, I had a huge suspicion on his (**Akhtar Huissain**) body language that he is trying to conceal some illegal items at the Almirah which was placed at his bed room. Then I opened the Almirah and found one black colour bag. On opening the black colour bag, found one transparent polythene containing some Spas Primevon capsules in loose form (not in strip form) suspected to be contained **Tramadol** and some codeine contained cough syrup bottles. On counting the suspected SP capsules found 118 nos. of suspected SP capsules weighing 76.5 grams and 13 nos. of "Nukol" cough syrup bottles containing codeine phosphate. On checking each bottles of cough syrup found containing 10 mg of codeine phosphate per 5 ml each (as per composition). On calculation weighing one bottle of cough syrup found contained (10X20 =200) mg of codeine phosphate, altogether 200X13 = 2600 mg i.e. 2.6 gram of codeine phosphate. On asking about the illegal drugs, **Aribam Akhtar Huissain** disclosed that the illegal drugs belonged to him and he kept it concealed inside the Almirah placed at his uncle namely Md. Walli's bed room.

Then in presence of the witnesses, I seized the detected Spas Primevon capsules and illegal cough syrup bottles from the unauthorised possession of **Aribam Akhtar Huissain (20)** yrs. S/o Md. Sanayai of Lilong Turel Ahanbi Khongnangkhong Mathak at 08:50 pm by observing formalities and arrested him at 9:00 pm from the spot.

It is therefore, arrested person along with the seized drugs is handed over to you for further legal action.
