Sub: - Report.

Sir.

I have the honour to report that on 25/03/2020 at about 09:00 pm I along with my Police party was conducting frisking and checking at Lilong Alia Lamkhai along the NH-102. While conducting so at about 09:20 pm one Maruti A-Star car bearing Regd. No. HR26BD-7342 silky silver in colour was coming from Lilong Alia IVR towards NH-102. Police Team gave stop signal for checking of the vehicle but the A Star car did not stop, instead the car drove very fast towards Thoubal side along the NH-102. As suspicious, my team chased the vehicle and managed to overpower it at Lilong Khunou along the NH-102 in front of Lilong PS at 09:30 pm. On checking, two individuals were found inside the car. On verification, they disclosed themselves as Makakmayum Rohid Khan (23) S/o Makakmayum. Nasimuddin of Lilong Khunou (Driver) & Jinmayum Fayas (20) S/o Jinmayum Sahidur of Lilong Heinou Makhong (owner of the car). On checking of the vehicle, found one black colour polythene suspected to be contained some illegal articles. As suspicious, it was opened in presence of the witness. On opening, found 51 (fifty one) bottles of Codirox cough syrup (100 ml each) containing codeine phosphate. On checking, found each bottle of Codirox cough syrup bottle contains 10 mg of codeine phosphate per 5 ml each (as per composition) which is a contravened substance under ND&PS Act. On calculation/weighing, one bottle of cough syrup contained  $10 \times 20 = 200$  mg of codeine (as per composition), altogether contained  $200 \times 51 = 10,100$  mg i.e. 10.1 grams of codeine phosphate. On spot examination, they disclosed that they are regular illegal drug sellers and they together bought it from one Mrs. Apik D/o Md. Zamaluddin of Lilong Haoreibi Mayai Leikai. Then, in presence of the witnesses, I seized the Maruti A-Star car bearing Regd. No. HR26BD-7342 and illegal cough syrup bottles from the unauthorized possession of Makakmayum Rohid Khan (23) S/o Makakmayum. Nasimuddin of Lilong Khunou at 09:50 pm of 25/03/2020. Hence they were arrested at 9:55 pm and 10:00 pm of 25/03/2020 respectively.

It is therefore, the arrested persons along with the seized articles is handed over to you further necessary action.


