Sub:- Report.

Sir,

I have the honour to report that on 08/04/2020 at about 05:30 pm, as part of the on-going total lockdown imposed in the state, I along with my team under the supervision of Dr. S. Ibomcha Singh, MPS, Superintendent of Police, Thoubal were conducting intensified frisking and checking at Lilong Litan Makhong near Alia Bridge. While conducting frisking and checking, one person was coming on foot towards Alia Bridge in a suspicious. Due to his suspicious manner, I stopped him for verification and on stopping, he turned back and tried to run away from the spot. We chased him and detained him. On verification, he identified himself as one Md. Zakir Hussain (53) yrs, S/o. (L.) Md. Samsuruddin of Lilong Yangbi Leikai. From his body language, it was suspected that he concealed some illegal articles in his right side pocket of his Kurta shirt. Then I informed him that I have reason to believe that he had concealed some illegal article and I would like to conduct his body search. I gave him option whether he liked to conduct his body search in the presence of civil witnesses or Gazetted Officer. Then he opted to conduct body search in presence of civil witnesses not before a Gazetted Officer. So, I call upon some members of civil organisation ALADA (All Lilong Anti-Drugs Association) and LBDC (Lilong Board Development Committee). With his consent, I conducted body searched of Md. Zakir Hussain in the presence of witnesses, in that, found one soap cap (red & blue) from his pocket. On opening the soap cap, found brown powder packed inside transparent polythene suspected to be Heroine No. 4. On weighing, it weighed 16.5 (sixteen point five) grams excluding the weight of the container.

Then, in presence of the witnesses, I seized the suspected Heroine No. 4 from the possession of Md. Zakir Hussain (53) yrs, S/o. (L.) Md. Samsuruddin of Lilong Yangbi Leikai at 06:50 pm of the day and arrested him at 07:15 pm of the day.


So, the arrested person along with the seized article is handed over to you for further necessary action.
