Today i.e. 12/04/2020 at 06.10pm, received a reliable information that on the same day at about 06.00 pm one car Swift D Zire bearing registration no. MN07D-0673 coming from Thoubal side towards Imphal side collided with one Honda Dio bearing registration no. MN01AF-9474 which was coming in opposite direction at Waithou Sangomsang corner near Stone Crusher along NH-102 due to the rash and negligent driving on the part of both the unknown drivers. As a result of which, the rider of Honda Dio along with pillion rider received serious injury on their persons and evacuated to RIMS Hospital, Imphal for Medical treatment. Both the vehicles were also partly damaged.

Hence, a suo motto case under **FIR No. 39(04)2020 LIL-PS U/s- 279/338/427 IPC** has been registered for investigation.
