

Sub: - Report.

Sir,

I have the honour to report that on 17/04/2020 from 1:00 pm to 8:00 pm, I along with my team was deployed at Lilong Bazaar for bazaar duty in c/w the ongoing Curfew/Lockdown imposed in the state due to the prevailing situation arising out of the outbreak of COVID-19 pandemic. While performing bazaar duty at about 7:00 pm, one Maruti A Star four wheeler car B/Rgd. No. MN06LA-1170 was coming towards Thoubal side from Imphal side along the NH-102. The Maruti A Star four wheeler car was detained for verification. On verification, he identified himself as Mv. Habibur Rahaman (67 yrs) S/o (L) Md. Ajijullah of Lilong Turel Ahanbi Kaleikhong Makha (driver of the car). On asking about the purpose for coming out at public place/road, he replied that he went to Kiyamgei to bring TALAB (Gutka-supari product) & chewing tobacco for selling purpose. He did not have any Curfew exemption pass from concerned authority also. It may be mentioned that there is restriction of transporting non-essential commodity items in Manipur vide Order No. 9/6(1)/2020-II(Pt) dated 23/03/2020, of the Chief Secretary, Govt. of Manipur. On checking of the vehicle, found 33,000 (thirty three thousand) pieces/pouches each of TALAB Royal PAN MASALA & T-5 Royal Chewing Tobacco. It may also be mentioned that there is strict ban on sale of Gutka, Tobacco, Pan etc vide DM/FBI order No. 7/42/DC(FBI)/DDMC/COVID-19/2020 dated 16<sup>th</sup> April, 2020. Accordingly, Mv. Habibur Rahaman (67 yrs) S/o (L) Md. Ajijullah of Lilong Turel Ahanbi Kaleikhong Makha was arrested at 7:45 pm of the day for disobedience to an order promulgated by a public servant, negligently, malignantly doing any act known to be likely to spread infection of any disease dangerous to life. The detected 33,000 (thirty three thousand) pieces/pouches each of TALAB Royal PAN MASALA & T-5 Royal Chewing Tobacco was seized at 8:00 pm of the day from his possession by observing formalities.

It is, therefore, the arrested person along with the seized article is handed over to you for further necessary action.
