Sub: - Report.

Sir,

I have the honour to report that on 17/04/2020 at about 9:50 pm, I along with my team was carrying out frisking and checking duty at Lilong Bazaar in c/w the ongoing Curfew/Lockdown imposed in the state due to the prevailing situation arising out of the outbreak of COVID-19 pandemic. While doing so at about 10:00 pm, one Renault Kwid four wheeler car B/Rgd. No. MN01AK-9177 was coming towards Thoubal side from Imphal side along the NH-102. The Renault Kwid four wheeler car was detained for verification. On verification, he identified himself as Md. Baharul (19 yrs) S/o (I) Haji Liyakat Ali of Lilong Makha Leikai (driver of the car). On asking about the purpose for coming out at public place/road, he replied that he went to Kiyamgei to bring TAI AB (Gutka-supari product) & chewing tobacco for selling purpose. He did not have any Curfew exemption pass from concerned authority also. It may be mentioned that there is restriction of transporting non-essential commodity items in Manipur vide Order No. 9/6(1)/2020-II(Pt) dated 23/03/2020, of the Chief Secretary, Govt. of Manipur. On checking of the vehicle, found 110 packets each of Talab Royal PAN MASALA & T-5 Royal Chewing Tobacco. Each packet contains 30 pouches. It may also be mentioned that there is strict ban on sale of Gutka, Tobacco, Pan etc vide DM/TBI order No. 7/42/DC(TBI)/DDMC/COVID-19/2020 dated 16<sup>th</sup> April, 2020. Accordingly Md. Baharul (19 yrs) S/o (I) Haji Liyakat Ali of Lilong Makha Leikai was arrested at 9:30 pm of the day for disobedience to an order promulgated by a public servant, negligently, malignantly doing any act known to be likely to spread infection of any disease dangerous to life. The detected 110 packets each of Talab Royal PAN MASALA & T-5 Royal Chewing Tobacco was seized at 10:45 pm of the day from his possession by observing formalities.


It is, therefore, the arrested person along with the seized article is handed over to you for further necessary action.
