Sub: - Report.

Sir,

I have the honour to report that on 20/04/2020 from 6:00 am to 12:00 noon, I along with my team was deployed at Lilong Bazar for Bazar duty in c/w the ongoing Curfew/Lockdown imposed in the state due to the prevailing situation arising out of the outbreak of COVID-19 pandemic. While performing bazaar duty at about 8:00 am, one unknown person holding one black colour polythene carry bag from Alia Bridge side towards Lilong Bazar side. The unknown person was detained for verification. On verification, he identified himself as **Thingujam Imomacha Singh (56 yrs) S/o (L) Th. Thambalngou Singh of Singjamei Makha Khongnang Pheidekpi**. On asking about the purpose for coming out at public place/road, he replied that he came to Lilong to buy BABA black DELUXE CHEWING TOBACCO and the black colour polythene carry bag contains BABA black DELUXE CHEWING TOBACCO. He did not have any Curfew exemption pass from concerned authority also. It may be mentioned that there is restriction of transporting non-essential commodity items in Manipur vide Order No. 9/6(1)/2020-H(Pt) dated 23/03/2020, of the Chief Secretary, Govt. of Manipur. On checking of the black colour polythene carry bag, found 2 (two) tin container of BABA black DELUXE CHEWING TOBACCO (200 grams each) & 10 (ten) tin container of BABA black DELUXE CHEWING TOBACCO (50 grams each). It may also be mentioned that there is strict ban on sale of Gutka, Tobacco, Pan etc vide DM/TBL order No. 7/42/DC(TBL)/DDMC/COVID-19/2020 dated 16th April, 2020. Accordingly, Thingujam Imomacha Singh (56 yrs) S/o (L) Th. Thambalngou Singh of Singjamei Makha Khongnang Pheidekpi was arrested at 8:30 am of the day for disobedience to an order promulgated by a public servant, negligently, malignantly doing any act known to be likely to spread infection of any disease dangerous to life. The detected 2 (two) tin container of BABA black DELUXE CHEWING TOBACCO (200 grams each) & 10 (ten) tin container of BABA black DELUXE CHEWING TOBACCO (50 grams each) was seized at 8:40 am of the day from his possession by observing formalities.

It is, therefore, the arrested person along with the seized article is handed over to you for further necessary action.
