I have the honour to lay the following few facts for kind perusal and sympathetic legal action against the accused person.

That on 18/4/2020 at about 8am - my younger brother in law Md. Manjur - (28) s/o md. Lamine of Amakham Adang Lekaie was going toward Telang Bazar driving my newly purchased Atilva No-NIL Blue in colour Chassis ME4JF - 50 AMKG 467653 Engine No JF 50E60 467748 worth Rs 70,000/- for purchasing medicine and on arrival at the above P.O. i.e. NH No 102 near Bari Zame - Masjid, Telang, the accused person suddenly dashed with my Atilva - due to the rash and negligently driving of the Atilva of the accused by the accused himself. and as a result of which my younger brother md. Manjur and lone occupant md. Kasim Ali of Amakham - village received serious injuries on their persons and my Atilva (above noted) also got badly damaged.

That both the injured persons i.e. md. Manjur and Kasim Ali were immediately moved to Rems Hospital for treatment pro

Now Md Manjur is in a serious condition under treatment at RIMS while the occupant Md. Kasim Ali was discharged after treatment.

That the accused Md. Tayeb-Ali 35 has committed offences -
Punishable u/s 279/338/427/12c.
