



On 06/05/2020 at about 11:45 pm two teams of Lilong PS led by Inspt. O. Ajit Singh, OC, Lilong PS assisted by SI Kh. Santosh Singh, SI Md. Isha Khan & ASI Laishram Tikendro of Lilong PS carried out patrolling duty at Lilong Haoreibi Makha Leikai area, in c/w the prevailing nationwide Lockdown imposed. At about 0:20 am of 07/05/2020 at Lilong Haoreibi Makha Leikai Konjil, one Maruti 800 AC B/Rgd. No. WB02T-1128 was seen coming in a high speed. As suspicious, the Maruti 800 AC B/Rgd. No. WB027-1128 was detained for verification and found two persons inside the car including the driver of the car. On verification, they identified themselves as Makakmayum Abdul Gaffar (33 yrs) S/o (L) Md. Abdul Zabar of Lilong Haoreibi Makha Leikai near Water Supply (Driver) & Yumkhaibam Mirza Khan (37 yrs) S/o Md. Sahidur Rahman of Lilong Haoreibi Makha Leikai near ICRO Office. On verification, they could not explain the authenticity of their late night movement. Due to non-availability of civil witnesses at the place, I called upon some volunteers of ALADA (All Lilong Anti-drug Association) at the place so as to witness while conducting legal formality. On arrival of the volunteers of ALADA, in presence of the witnesses I conducted the thorough search of the car. On searching, found one Mobile handset Redmi Note 7 Pro lying on the front left side seat & one black colour polythene carry bag beneath the front left side seat. The black colour polythene carry bag was opened in presence of the witnesses and found 4 (four) Nos. of pink colour soap cap, 4 (four) Nos. of blue colour soap cap, 1 (one) red colour soap cap, 1 (one) green colour soap cap and 1 (one) transparent Frooti bottle. The 4 (four) Nos. of pink colour soap cap was marked as P1, P2, P3 & P4 for identification. Similarly, 4 (four) Nos. of blue colour soap cap was marked as B1, B2, B3 & B4, 1 (one) red colour soap cap was marked as R, 1 (one) green colour soap cap was marked as G and 1 (one) transparent Frooti bottle was marked as F. On opening the soap caps, found each caps containing brown colour powder suspected to be Heroin No.4 (Opium Derivatives) packed in transparent thin polythene pouches. On opening the transparent Frooti bottle, found containing brown colour powder suspected to be Heroin No.4 (Opium Derivatives). On weighing, the powder substances containing in 4 (four) Nos. of pink colour soap cap. it weighed 11.6 grams for P1, 10.6 grams for P2, 12.5 grams for P3 and 12.5 grams for P4 respectively including the packed transparent thin polythene pouches. On weighing, the powder substances containing in 4 (four) Nos. of blue colour soap cap, it weighed 12.3 grams for B1, 11.5 grams for B2, 12.8 grams for B3 and 10.8 grams for B4 respectively including the packed transparent thin polythene pouches. On weighing, the powder substance containing in 1 (one) red colour soap cap marked as R, it weighed 11.9 grams including the packed transparent thin polythene pouch. On weighing, the powder substance containing in 1 (one) green colour soap cap marked as G, it weighed 12.5 grams including the packed transparent thin polythene pouch and on weighing, the powder substance containing in the transparent Frooti bottle marked as F, it weighed 13 grams including the weight of the the transparent Frooti bottle. On asking about the suspected Heroin No.4, they disclosed that they are drug dealer and they bought it from Sora (full particulars not known) for selling purpose. Hence, Makakmayum Abdul Gaffar (33 yrs) S/o (L) Md. Abdul Zabar of Lilong Haoreibi Makha Leikai near Water Supply (Driver) & Yumkhaibam Mirza Khan (37 yrs) S/o Md. Sahidur Rahman of Lilong Haoreibi Makha Leikai were arrested at 1.00 am and 1:05 am of 07/05/2020 respectively. In presence of the witnesses, seized the detected drugs & Mobile handset Redmi Note 7 Pro from the possession Yumkhaibam Mirza Khan (37 yrs) S/o Md. Sahidur Rahman of Lilong Haoreibi Makha Leikai at 1:10 am of the day. Further, the Maruti 800 AC B/Rgd. No. WB02T-1128 was seized at 1:15 am of the day from the possession of Makakmayum Abdul Gaffar (33 yrs) S/o (L) Md. Abdul Zabar of Lilong Haoreibi Makha Leikai.

Hence, suo moto case under **FIR No. 48(5)2020 LIL-PS U/s 21(b)/29/60(2) ND & PS Act** has been registered for investigation.
