Today i.e. 10/05/2020 at around 7:40 pm received reliable information that some unknown persons suspected to be habitual vehicle lifters/hijackers have gathered at Lilong Ushoipokpi area near Lilong Tamyai Crossing with an ulterior motive for selling/disposal of stolen vehicles. Immediately, two teams of Lilong PS led by Inspector O. Ajit Singh, Officer-in-Charge, Lilong Police Station assisted by SI Kh. Santosh Singh and ASI L. Tikendro of Lilong PS rushed at the said area. As soon as Police Teams approached there, some unknown persons were seen moving at different directions. Police Teams cordoned and searched every nook & cranny. Afterwards, one Maruti Swift car bearing registration number - Nil, engine number - K12MP1033548, chassis number - MBHCZC63SKD407613 suspected to be stolen vehicle was found abandon at the roadside of Lilong Tamyai Crossing road and fled away the lifters/culprits in the darkness. Immediately, we pursued them but in vain. It is suspected that the vehicle was abandoned there after the lifters/culprit had stolen it from an unknown place. The same vehicle was seized at 8.30 pm of the day and brought to Lilong Police Station.

Hence, a suo motto case under FIR No. 49(5)2020 LIL-PS U/s 379/34 IPC has been registered for investigation.
