
Sir,

I have the honour to report that on 11/05/2020 at around 5:20 pm, while I was at my office i.e. Lilong Police Station, received specific information from my personal source that one person namely Singamayum Sadiqur Rahman 47yrs, S/o (L) Md. Abdul Jabar of Lilong Haoreibi Turel Ahanbi near Darul Uloom is selling illegal drug i.e. WY (Amphetamine) tablets at his house and some unknown drug users are gathered at his house. I had taken down the information in writing and a similar copy of the same was forwarded to SP/Thoubal for information and further necessary action. Immediately, I along with my team rushed to the said place without obtaining search warrant/authorization as there was great chance of escape of the offender and concealing the drug. I called upon some volunteers of ANJUMAN at the place so as to witness while conducting legal formality. At about 5:40 pm when Police Team reach at his house, three persons were sitting at the house verandah of Singamayum Sadiqur Rahman 47yrs, S/o (L) Md. Abdul Jabar of Lilong Haoreibi Turel Ahanbi near Darul Uloom. On seeing the Police team, they dispersed and tried to run away but Police team managed to detain them. On verification, they identified themselves as (1) Singamayum Sadiqur Rahman 47yrs, S/o (L) Md. Abdul Jabar of Lilong Haoreibi Turel Ahanbi near Darul Uloom (2) Phundreimayum Rahimuddin @ Mani 48yrs S/o (L) Md. Zamaruddin of Lilong Haoreibi Makha Leikai Lairabakhong and (3) Yumkhaibam Wahidur 32yrs S/o Mv. Ashrab Ali of Lilong Haoreibi Makha Leikai Asem Leirak. Detained person Singamayum Sadiqur Rahman 47yrs was holding one transparent polythene carry bag on his left hand. On asking, he disclosed that it was WY (Amphetamine) tablets and he threw it on the ground. In presence of witnesses, the transparent polythene carry bag was picked up and opened. On opening, found some pink colour and paled pink colour tablets suspected to be WY (Amphetamine) tablets wrapped in a white plain paper. On counting, found 70 (seventy) number of pink colour tablets suspected WY (Amphetamine) tablets and 36 (thirty six) number paled pink colour tablets suspected WY (Amphetamine) tablets. On weighing, 70 (seventy) number of pink colour tablets weighed 6.9 grams and 36 (thirty six) number of paled pink colour tablets weighed 3.4 grams. On questioning, he (Singamayum Sadiqur Rahman) disclosed that he is an illegal drug seller and he was about to sell it (detected drug) to the above noted detained persons namely Phundreimayum Rahimuddin @ Mani and Yumkhaibam Wahidur. So, in presence of the witnesses, the detected drugs were seized at 6:10 pm of the day and arrested him at 6:15 pm of the day by observing formalities.

On examination of detained persons namely Phundreimayum Rahimuddin @ Mani and Yumkhaibam Wahidur, they disclosed that they are drug users and they came there to buy WY (Amphetamine) tablets for their personal consumption. So, Phundreimayum Rahimuddin @ Mani and Yumkhaibam Wahidur were also arrested at 6:20 pm and 6:25 pm of the day respectively.

It is therefore, the above noted seized illegal drugs and arrested persons are handed over to you for taking necessary legal action.
