Today i.e. on 13/05/2020 at around 4:00 pm, while I was at my office i.e. Lilong Police Station, received specific information from my personal source that Md. Ayub Khan aged about 47 yrs, S/o Md. Allauddin of Lilong Turel Ahanbi Dam Makha and his wife namely Zulekha @ Abem aged about 28 yrs are selling illegal drug such as WY (Amphetamine) tablets, SPAS PRIMEVON capsules at their house and some quantity of the said drugs are still kept concealed at their house. I had taken down the information in writing and a similar copy of the same was forwarded to SP/Thoubal for information and further necessary action. Immediately, I along with my team including Women Police Constables rushed to the said place without obtaining search warrant/authorization as there was great chance of escape of the offender and concealing the drug. I informed the information to Shri H. Johny Sharma, MPS (SDPO/TBL) and requested him to come at the spot. I also called some volunteers of ANJUMAN to come at the place to witness while conducting legal formality. On reaching the spot, while Police Team was trying to cordon the house, suddenly, one male person ran away from the house through the back door of the house. Immediately, Police Team chased him but the individual managed to escape. Thereafter, one woman was found inside the house and on verification, she identified herself as Zulekha @ Abem aged about 28 yrs W/o Md. Ayub Khan of Lilong Turel Ahanbi Dam Makha. She stated that the escaped man was her husband namely Md. Ayub Khan aged about 47 yrs, S/o Md. Allauddin of Lilong Turel Ahanbi Dam Makha. Then, I informed her that I have reason to believe that she and her husband are selling illegal drugs such as WY (Amphetamine) tablets, SPAS PRIMEVON and some quantity of the said drugs are still kept concealed at their house and I would like to conduct house search. Then, in presence of Shri H. Johny Sharma, MPS (SDPO/TBL) and civil witnesses, I conducted house search. During the search, found one black colour and one brown colour polythene carry bags suspected to contain illegal articles, kept concealed behind one black colour water sintex, placed inside the front right side room of the house. In presence of the witnesses, the two polythene carry bags were picked up and opened. On opening of black colour polythene carry bag, found some pink colour tablets and some paled pink colour tablets suspected to be WY (Amphetamine) tablets. On opening of brown colour polythene carry bag, found some blue colour cylindrical capsules marked as SPAS PRIMEVON and some cash amount. On counting, found 123 (one hundred twenty three) number of pink colour tablets, 1019 (one thousand nineteen) number of paled pink colour tablets, 74 (seventy four) number of SPAS PRIMEVON capsules and cash amount of Rs. 43, 700/- (forty three thousand and seven hundred) only respectively. On asking about the detected tablets and capsules, the woman disclosed that pink and paled pink colour tablets were WY (Amphetamine) tablets and blue colour cylindrical capsules was SP capsules. She also disclosed that the detected cash amount of Rs. 43, 700/- (forty three thousand and seven hundred) only was sale proceed of illegal drug. She and her husband jointly supplied illegal drugs to many of their near and far customers. On weighing, 123 (one hundred twenty three) number of pink colour tablets weighed 13 grams, 1019 (one thousand nineteen) number of paled pink colour tablets weighed 103 grams and 74 (seventy four) number of SPAS PRIMEVON capsules weighed 39 grams. On questioning, she disclosed that she and her husband are illegal drug sellers and they have been engaging in such type of illegal business since long back. They used their Tata Magic ACE white in colour B/Rgd. No. MN01W-5035 which was found at the courtyard of their house, to transport/carry illegal drugs. So, in presence of the witnesses, the detected drugs, detected cash amount of Rs. 43, 700/- (forty three thousand and seven hundred) only and Tata Magic ACE white in colour B/Rgd. No. MN01W-5035 was seized at 5:00 pm of the day and arrested her at 5:05 pm of the day by observing formalities.

Hence, a suo motto case under FIR No. 52(5) 2020 LIL-PS U/s 21(a)/22(c)/29/60 ND&PS Act for investigation.
