Sub:- Report.

Sir,

I have the honour to report that on 19/05/2020 at around 10:30 pm, received specific information from my personal source that one Tata Truck (12 Chaka) bearing Rgd. No. MN01-9755 carrying a huge quantity of illegal cough syrup bottle was going to be unloaded somewhere at Lilong Nungei Dolaithabi area. I had taken down the information in writing and a similar copy of the same was forwarded to SP/Thoubal for information and further necessary action. Immediately, two teams of CDO Unit, Thoubal led by me (Jem. Md. Amin Khan) and Hav. Md. Kamal Hassan & two teams of Lilong PS led by Inspt. O. Ajit Singh, OC, Lilong PS & SI Kh. Santosh Singh assisted by ASI L. Tikendro of Lilong PS rushed to the said place without obtaining search warrant/authorization as there was great chance of escape of the offender and concealing the drug. I informed the information to Shri Sachidananda Soibam, MPS, Addl. SP (Ops), TBL and requested him to come at the spot. On reaching at Lilong Nungei Dolaithabi, Police teams conducted minute search to trace out the Truck. At about 11:00 pm of the day, the said Tata Truck (12 Chaka) was found parked at Lilong Nungei Dolaithabi Lampak. On checking, driver of the Tata Truck who identified himself as Md. Hashim (26) S/o Md. Muhi Mia of Lilong Nungei Khunou was found sitting inside the Tata Truck. Then, I informed him that I have reason to believe that he has carried a huge quantity of illegal cough syrup bottles in your Tata Truck (12 Chaka) bearing Rgd. No. MN01-9755 for unloading it to somewhere at Lilong Nungei Dolaithabi area and I would like to conduct search of Tata Truck (12 Chaka) bearing Rgd. No. MN01-9755. Then, in presence of Shri Sachidananda Soibam, MPS, Addl. SP (Ops), TBL and witnesses, I conducted search of the Tata Truck. During the search, found 36 (thirty six) carton boxes marked as **DASLIN-CD + COUGH SYRUP 100 ML** suspected to contain illegal articles, kept concealed in between sofa seats, placed in the body of the Tata Truck. Then, unloaded the 36 (thirty six) carton boxes marked as **DASLIN-CD + COUGH SYRUP 100 ML**. In presence of Shri Sachidananda Soibam, MPS, Addl. SP (Ops), TBL and witnesses, the carton boxes were opened. On opening, 35 carton boxes containing 100 Nos. of **DASLIN-CD + cough syrup bottle (100 ml each)** each and remaining 1 carton box containing 99 Nos. of **DASLIN-CD + cough syrup bottle (100 ml each)** i.e. altogether 3,599 Nos. of **DASLIN-CD + cough syrup bottle (100 ml each)**. On checking, each bottle of **DASLIN-CD + cough syrup bottle** contains 10 mg of codeine phosphate per 5 ml each (as per composition) which is a contravened substance under ND&PS Act.

On asking about the detected illegal cough syrup bottles, he disclosed that he brought it from Guwahati in his Tata Truck (12 Chaka) bearing Rgd. No. MN01-9755 and owners of the illegal cough syrup bottles is Md. Mustak @ Feroz Khan (35) S/o Md. Amu of Lilong Turel Ahanbi Boroi Makhong and Md. Baboi (24) S/O Mm Abothem of Lilong Turel Ahanbi Aribam Salam Mathak. So, in presence of the witnesses, the detected illegal cough syrups i.e. 3,599 (three thousand five hundred ninety nine) **DASLIN-CD + cough syrup bottle (100 ml each)**, Tata Truck (12 Chaka) bearing Rgd. No. MN01-9755 and one mobile handset VIVO-1716 used by him was seized at 11:40 pm of the day and arrested him at 11:45 pm of the day by observing formalities.
